The United Nations Development Programme (UNDP) partners with people at all levels of society to help build nations that can withstand crisis, and drive and sustain the kind of growth that improves the quality of life for everyone. The Participants Committee (PC) at its ninth meeting in June 2011 approved UNDP to serve as Delivery Partner under the Readiness Fund. The Transfer Agreement was signed between the World Bank, acting as the Trustee of the FCPF, and the UNDP on August 9, 2012.

To ensure a uniform set of safeguard standards, the Common Approach to Environmental and Social Safeguards for Multiple Delivery Partners was also approved at the ninth FCPF PC meeting. The Common Approach is designed to provide the World Bank and the Multiple Delivery Partners with a common platform for risk management and quality assurance in the REDD+ Readiness Preparation process which is substantially equivalent to the World Bank's applicable policies and procedures on environmental and social safeguards, disclosure of information, and grievance and accountability mechanisms.

2019 Results

1. Achievements

This report highlights activities and results achieved by the Forest Carbon Partnership Facility Read+Readiness Project phase two (FCPF II) carried out by the Cambodia REDD+ Secretariat from January to December 2019.

The project continues to enhance and build capacity for REDD+ readiness, ensure effective management of the national REDD+ process and continues to be engaged in the implementation of REDD+ readiness activities through the REDD+ Taskforce (RTF), REDD+ Taskforce Secretariat (RTS), the Technical Teams (TTs) and Gender Group (GG). Effective participation of stakeholders in the REDD+ readiness remains strong and consistent through the active participation of the Consultation Group (CG). The Capacity building of these institutions and stakeholders' engagement for REDD+ implementation has progressed well and continued to be strengthened through their engagement in trainings, meetings, workshops, south-south exchanges and knowledge sharing events in accordance with their mandate.

Multiple events¹ were organized during this period, including consultations on (i) the development of the action and investment plan for the implementation of the National REDD+ Strategy (AIP-NRS), (ii) the drafting of the first Summary of Information (SoI) on safeguards, (iii) the development process of a nested system for REDD+ implementation and (iv) the drafting of the REDD+ Technical Annex of the 1st Biennial Update Report (BUR) . Those events, counted with the participation of key government institutions, development partners, private sectors and NGOs/IOs. REDD+ awareness-raising workshops for university students at subnational levels were also conducted. These events have contributed to raising awareness and knowledge on forest, climate change and REDD+, it's co-benefits and on the progress towards its implementation. Overall, 1,329 representatives (390 women) from diverse stakeholder's groups have benefited from these multiple events.

Regarding technical and strategical advances for Cambodia to move from REDD+ readiness to implementation stage, the project has made significant progress in 2019 to fulfil all the requirements for results-based payment from REDD+ under UNFCCC. Therefore the REDD+ in Cambodia, with the support of FCPF, has finalized numbers of key remaining readiness documents including: (i) the AIP-NRS, (ii) the First Summary of Information (SoI), (iii) the Greenhouse Gas Inventory (GHG-I) and the mitigation chapters of the first BUR and (iv) the REDD+ Technical Annex (TA) of the BUR. Other technical activities, that were initiated in 2018, continue to make significant progress in 2019 towards finalization. These include the land-use finance mapping (i.e. the inventory of public and private investments linked to the land-use sector) and the designing of a nested system for REDD+ implementation (i.e. how to coordinate, incentivize and monitor REDD+ implementation at different spatial scales).

a. Progress on how the project activities are being coordinated with other REDD+ related initiatives included those funded by others.

The FCPF-II project continued to support the operation of institutional arrangements for the management of the REDD+ process, including the operation of the RTF, RTS, CG, GG and TTs.

The National Council for Sustainable Development (NCSD), with its core mandate as an inter-ministerial

council, was supported on sustainable development priorities and to coordinate across ministries. The NCSD has been appointed the RGC focal point for the UNFCCC and oversees the Department of Climate Change and Green Economy and has become an important institutional partner for REDD+ planning and implementation. The FCPF project has taken lead in providing support to NCSD in development of the Greenhouse Gas Inventory (GHG-I) and the mitigation chapters of the first Biennial Update Report (BUR).

The RTF was initially established to oversee the implementation of the UN-REDD National Programme and continues to date to oversee the implementation of the FCPF grant. The RTF continues to govern and coordinate the development and implementation of REDD+ process in Cambodia, provide oversight to improvements in forest resource governance, foster inter-ministerial collaboration, advise on the RGC's position in international conventions and provide guidance on financial resources and sustainability. RTF met at least 2 times a year, where all REDD+ related initiatives and development partners have been invited to participate and share their REDD+ projects implementation experiences and vis versa to ensure integration and harmonisation of REDD+ implementation under the national REDD+ programme.

The RTS continues to be responsible for the effective day-to-day management of REDD+ in Cambodia through the implementation of RTF decisions and agreed annual work plans, and by providing support to the operation of the CG, the GG and the four TTs.

At the technical level, the four TTs, whose members are from seven sectorial Ministries, continue to lead and provide inputs on subject matter issues, and the CG and GG ensure stakeholders' inputs.

In addition to the collaboration with and support to the RTF and RTS in its effort to coordinate and implement national REDD+ programme, the project has continued to closely collaborate with the following agencies/projects for REDD+ readiness activities: UNDP, Food and Agriculture Organization of the United Nations (FAO), Japanese International Cooperation Agency (JICA) and other development partners through RTS, ensuring that alignment and complement both financial and technical supports to ensure that all initiatives have contributed to preparing Cambodia for implementation of REDD+ under the UNFCCC. Besides, several initiatives led by UNDP, UN-REDD Community-Based REDD+, Non-Governmental Organizations (NGOs) (such as the Wildlife Conservation Society (WCS) and Conservation International (CI)), Greening Prey Lang Project funded by USAID have established REDD+ demonstration projects in different landscapes across the country. At the technical and strategical level, REDD+ development partners have been closely collaborated to share field experiences and engage in the development of REDD+ related policies and strategy particularly in the designing of the nested system for REDD+ implementation in Cambodia and the development of the AIP-NRS. At the regional level in close coordination with FAO Head quarter (HQ) in Rome a technical training on data collection using Collect Earth was conducted from 27 to 28 May 2019 to 20 (4 women) Monitoring, Reporting and verification (MRV) Technical Team and participants from Ministry of Environment (MoE), Ministry of Agriculture, Forestry and Fisheries (MAFF), Forestry Administration (FA), Fisheries Administration (FiA) and Royal University of Agriculture (RUA) attended this workshop. In addition, in collaboration with Silva Carbon, training on the calculation of emissions/absorptions of the agriculture, forestry and land use (AFOLU) sector using the Gain-Loss Method (currently, the team is using Sock difference) using agriculture and land use (ALU) tool was conducted. Those trainers will carry on a Mapathon to collect information of drivers of deforestation and forest degradation all around the country Currently, data interpretation to estimate the uncertainties of Land use, Land use Change and Forestry (LULUCF) maps has been gathered and data analysis in underway to make the uncertainty analysis of the LULUCF maps for the period 2014-2016 and 2016-2018. In addition, a methodology to improve the minimum mapping unit of land use maps has been tested.

b. Important changes in the technical design or approach related to the project activities

There were no substantial changes to the technical design or approach related to project activities in 2019.

2. In Focus

In 2019, the RTF and RTS, with technical support from UNDP, FAO and specialized consulting firms, continue to make significant progress towards the finalization of the four pillars of the Warsaw Framework for REDD+.

A. Action & Investment Plan of the National REDD+ Strategy (AIP-NRS)

The final draft of AIP-NRS and the monitoring and evaluation (M&E) framework has been developed. The action and investment plan (AIP) detail the concrete actions and related investments required for the implementation of the NRS, prioritizing the various medium and long-term activities and areas targeted for intervention. For the three strategic objectives (SOs) of the NRS, the base implementation cost is USD 154 million. Phase I (2017-2021) requires USD 73.3 million and Phase II (2022-2026) requires USD 47.5 million. A further USD 33.3 million is required to complete implementation of the National Protected Area Strategic Management Plan (NPASMP), Production Forests Strategic Plan (PFSP) and Strategic Plan for Fisheries Conservation and Management (SPFCM) which are critically linked to successful NRS outcomes.

B. Safeguards Information System (SIS)

The Safeguards Information System (SIS) together with the first SoI for Cambodia has been completed, endorsed by chairman of the National Council for Sustainable Development (NCSD) and has already been officially submitted to and posted in the UNFCCC web portal. The first SoI presents how Cambodia will address and respect Cancun Safeguards during REDD+ implementation and identifies key modalities and practical arrangements that will be promoted and are in line with national policies, laws and regulations and relevant international treaties and conventions. The SoI analyses the potential social and environmental risks that may be linked to REDD+ implementation and suggest appropriate remedial measures to mitigate those risks. The SoI also provides key indicators for gathering relevant information on how REDD+ safeguards will be addressed and respected throughout the implementation of REDD+ policies and measures.

C. Gender mainstreaming

Gender assessment report on mainstreaming gender in REDD+ implementation has been completed and endorsed by RTS. Based on the results of this assessment, a training workshop on gender-integrated in REDD+ planning and action was successfully conducted on 25-27 March 2019. 28 participants (22 female) representing government institutions and national NGOs partners had their capacity and skills built on gender analysis, participatory methods and planning to integrate gender in REDD+ particularly in the implementation of Cambodia's national REDD+ action and investment plan that will lead to bringing about change for more gender-responsive practices. Gender Group work plan for 2019 to translate the findings of the assessment into implementation at the subnational level has also been developed and agreed by the Gender Group.

All REDD+ activities shall ensure 'do no harm' to women and enhance benefits to both women and men in an equitable manner. To achieve this, gender mainstreaming in REDD+ activities is an important step. On a two-days intensive training, 25-26 Nov, Gender REDD+ Group provides training to three REDD+ Subnational Demonstration Projects that receive Forest Carbon Partnership Phase II grants to promote gender considerations through their project's activities. The training participated by a total number of 43 people (18 women and 1 IP) who are project managers at national level, key focal points at provincial, district and commune levels, and representatives from communities including women groups and Indigenous people. The training had contributed to enhance capacity of participants not only to understand about gender concept and problem analysis, but able to design activities in more gender responsive, equitable, and inclusiveness.

D. Forest Reference Level (FRL) & National Forest Monitoring System (NFMS)

The Greenhouse Gas Inventory (GHG-I) and Mitigation Actions (MAs): The Greenhouse Gas Inventory (GHG-I) time series data for all sectors AFOLU, energy, industry and waste) has been completed. The final draft of GHG-I and GHG-I MAs charters of the 1st BUR has been submitted to NCSD for inclusion in the preparation of the first BUR for Cambodia.

The LULUCF maps of 2016-2018 are completed, statistics and booklets were finalized and under endorsement by MoE. The emission factors for the Flooded Forest has been collected. With support from FAO, a team of the RUA is collecting Lianas sampling. The of the national forest inventory (NFI) field manual, that is needed to implement the data acquisition of forest inventories, has been translated to Khmer.

The Mapathon to collect information of drivers of deforestation and forest degradation all around the country conducted. The analysis of data has been completed and the report is finalized. Building on the completion of the Mapathon, the uncertainty analysis was run for each period of the Forest Reference Level-FRL (2006-2014) and post FRL (14-16 and 16-18). Following those results, UNDP and FAO have completed the Biennial Updated Report Technical Annex (BUR-TA). Thus far, the final draft of BUR-TA, that reported on progress made by Cambodia on Reducing Emissions from REDD+ from 2015 to 2018, has been developed and is under final review and finalization by the MOE before submitting to UNFCCC for claiming results-based payment from REDD+ implementation. Besides, the NFMS web portal was updated with the 2006, 2010 and 2014 LULUCF maps using the Intergovernmental Panel on Climate Change (IPCC) classification.

Also, there have been developments on the spatial monitoring at national scale using cloud solutions to confirm the global alerts on forest loss (GLAD alerts). Finally, the methods to do LULUCF maps and estimate the deforestation is under review, this include the revision of the minimum mapping unit and the forest classes of the maps. The review of the method includes new datasets from SERVIR Mekong and the integration of them into cloud systems (Google Earth Engine) are also being developed.

In addition to the international requirements to comply with the Warsaw Framework for REDD+ under the UNFCCC, the design of the domestic REDD+ implementation framework was also initiated in 2019. In that regard, key highlights of 2019 include:

- Design of the Nested System for REDD+ implementation: As part of the design process, options for nesting subnational REDD+ projects within the national REDD+ programme have been identified and discussed with the government and development partners. As a result of these consultations, a three-staged approach and associated recommended actions has been developed (a) a "pre-nesting" stage; (b) an "early nesting" stage and (c) the final "fully nested" stage. Thus far, the technical note describing the staged approach for the design of the nested system has been shared officially by the RTF to relevant DPs and REDD+ project partners for information and constructive support. Work for the development of the early nesting stage is expected to start in early 2020.
- Land Use Finance Mapping: Multiple investments from both public and private sectors are made in Cambodia to support the development of various sectors (such as the agriculture, forestry, energy, mining and infrastructure sectors) that may have an impact on forests. However, not much information is known about overall existing investment, sources of finance and its pattern, and the potential impact of these financial flows on forests and forest cover. To understand this better, the FCPF project and the European Forest Institute (EFI) have initiated a study on Landuse Finance Mapping in Cambodia. In 2019, the land use typology for Cambodia has been finalized and data collection and analyses are being conducted. The final report, which will be used to inform policymakers, development partners and other stakeholders interested in sustainable land use, will be shared and discussed in 2020.
- Development of options for resources mobilization for AIP-NRS implementation: A draft project concept note on "REDD+ Integrated Project for a net Zero-Deforestation Jurisdiction in Stung Treng Province in Cambodia" has been developed in 2019. This concept note is expected to be proactively used for resources mobilization through the Green Climate Fund Simplified Approval Process funding scheme and or other interested Development Partners in 2020. The objective of this project is (i) to support Cambodia to comply with UNFCCC requirements for REDD+ Results-Based Payments and (ii) to implement innovative REDD+ demonstration activities (component 2) on the ground to address drivers of deforestation. One of the key project activities will be to mainstream REDD+ into development projects in the Stung Treng pilot Province, aiming in ensuring that REDD+ conscious choices are made when assessing potential location of development projects related to the land use sector. This project would support the implementation of the NRS. Currently the concept note is awaiting UNDP internal clearance before submission to the GCF.

3. Risks, Issues and Responses

Under the FCPF-II project, UNDP has supported the Cambodia RTF to officially submit all the required elements to comply with the Warsaw Framework for REDD+ under the UNFCCC, including the National REDD+ Strategy (NRS, 2018), The Forest Reference Level (FRL, 2017), the National Forest Monitoring System (NFMS, 2016) and the Safeguards Summary of Information (SoI, 2019). These completions are an important foundation for Cambodia to potentially access results-based payments (RBP) and to transition from the REDD+ readiness phase towards implementation. Just as importantly, the FCPF-II project supported the RTF to prepare the Action and Investment Plan for the implementation of the National REDD+ Strategy (AIP-NRS) over the 2019-2030 period.

Although Cambodia succeed in completing the UNFCCC requirements to claim Results-Based Payments, the following lessons and way forward are critical to support transition from REDD+ readiness to REDD+ implementation and results-based payment in Cambodia.

A. The need to ensure high-level government commitment and support for the implementation of the Action and Investment Plan of the National REDD+ Strategy (AIP-NRS).

Currently, FCPF-II supported RTF/RTS to develop options for resources mobilization for AIP-NRS implementation in Cambodia. Project concept note to the GCF-SAP and or interested Development Partners is also being finalized to seek funding support to implement AIP-NRS in Stung Treng province. However, to ensure successful implementation of the AIP-NRS, full support and strong commitment from RCG must be secured. FCPF II is working with RTF/RTS to organize "High-level presentation" of the AIP-NRS to seek for such a support and commitment.

B. The need to test the Safeguards Information System (SIS):

Although Cambodia has finalized the development of the SIS and has submitted the first Summary of Information (SoI) to the UNFCCC, thus far, testing the operationalizing of the SIS has only focused on assessing the environmental and social risks and associated management options from the implementation of REDD+ pilot activities with (i) General Department of Administration, Nature Protection and Conservation (GDANCP) on protected area zoning, (ii) FA on woodlot establishment and biodigesters installation, and (iii) FiA on flooded forest restoration. To ensure full operationalization, FCPF should continue to support RTS to document REDD+ safeguards implementation in these pilot projects under the FCPF fund and to start input data into SIS database. Decision on period and scope and scale of data content and collection are very important to claim RBP in the future.

C. The need to ensure continuous support to the RTF/RTS and to maintain a coordination mechanism at national level for REDD+ implementation:

The FCPF II project currently provides operation and technical support for the coordination of the REDD+ programme at national level, including the support to the RTF, RTS, Technical Teams, and the Consultation and Gender Groups. However, the FCPF II project will be operationally closed by the end of 2020, which may jeopardize effective operations of the RTF/RTS and hence the coordination of the REDD+ programme at national level. As part of the AIP-NRS development process, to better reflect the current capacities and to move from REDD+ readiness to REDD+ implementation and RBP stages, FCPF II is working with RTF/RTS to reform the institutional arrangements and to design the financial architecture for REDD+ implementation with the aim of sustaining continuous financial and technical support to allow RTF/RTS to keep coordinating the REDD+ programme at the national level.

4. Progress in addressing key capacity issues of the Programme Management Unit (implementation, technical, financial management, procurement) related to this project

A clearly defined project management structure exists and consists of a Project Executive Board (PEB) that oversees project activities, performance and results. The National Project Director (NPD), National Project Manager (NPM) and staff at the RTS provide technical and administrative support to the project.

Annual work plans and budgets (AWPB) are approved and signed by the PEB. Based on the AWPB, the quarterly work plan and budget (QWPB) is prepared and endorsed by the NPD and submitted to UNDP for fund transfer to the government's project account for the implementation of activities. Both the AWPB and QWPB have been used as a basis for monitoring and evaluating project implementation progress with the government and other stakeholders during PEB, RTF and RTS meetings. Overall project implementation progress is satisfactory, including financial delivery.

Implementation of the project has been regularly monitored and assured by UNDP staff, such as regional advisors, programme analysts and associates. The UNDP Cambodia Country Office has also provided additional services such as for the recruitment of key project personnel, procurement of goods and services, and identification and facilitation of training activities in accordance with the Letter of Agreement between UNDP and the Government for the Provision of Support Services.

The project implementation follows the UNDP National Implementation Modality (NIM). Quarterly and annual progress reports together with fund authorization certification of expenditure (FACE) reports have been regularly prepared and submitted to UNDP. Meetings² of the PEB, RTF and RTS have been conducted to review progress, discuss and endorse quarterly and annual work plans. Project risks and issues log has been reviewed and updated every quarter and uploaded in the UNDP ATLAS system. Periodic field visits have also been conducted, jointly with RTF, RTS, TTs, CG and UNDP Project staff. The annual progress report to FCPF for Cambodia prepared and submitted by UNDP as part of its Delivery Partner responsibility under the FCPF and the REDD+ annual country progress reporting with semi-annual update (based on the FCPF Monitoring and Evaluation Framework and its logical framework and Performance Measurement Framework) have also been regularly prepared and submitted as per the requirements.

As per UNDP requirements the FCPF project is required to undergo an internal spot check undertaken by UNDP Country Office staff, and an audit undertaken by an independent agency. The FCPF project has been through these processes every year of implementation. A spot check was also undertaken by an independent agency since 2016 as advised by UNDP. The recommendations of the spot check and audit concluded that the implementation, technical, financial and procurement related to the FCPF project have been implemented and prepared, in all material respects, in accordance with the basis of preparation and accounting policies. There were no major issues identified.

Additional technical support was also provided through access to an external expertise pool locally and internationally, regional experts or institutions from the region as and when the PMU identifies the need. UNDP has also provided support, particularly for compiling lessons learned and sharing experiences with other stakeholders locally and internationally.

5. Progress in addressing social and environmental issues (including safeguards) related to the project. Is the SESA conducted in accordance with the Common Approach? Is the ESMF prepared in accordance with the Common Approach?

Countries wishing to participate in REDD+ are requested by the UNFCCC to address and respect a set of seven social and environmental safeguards - commonly referred to as the Cancun Safeguards - throughout the implementation of REDD+ activities. By applying the safeguards, countries can enhance the positive impacts of REDD+ and prevent or mitigate any potential adverse impacts. In addition to addressing and respecting the safeguards, countries implementing REDD+ under the UNFCCC are required to: a) develop a system for providing information on how the Cancun safeguards are being addressed and respected, i.e. a SIS; and b) provide SoI on how all the Cancun safeguards are being addressed and respected throughout the implementation of REDD+ activities. By end 2019, Cambodia have successfully developed SIS and the first SoI for Cambodia endorsed by H.E Say Samal, Chairman of the National Council for Sustainable Development (NCSD). The SoI has been officially submit to UNFCCC.

In addition, to ensure safeguards are address and respect throughout REDD+ implementation on the ground, Cambodia have also finalized the Environmental and Social Management Framework (ESMF) highlighting the need to avoid and mitigate the impact on biodiversity, Indigenous people, Gender and Resettlement when implementing all kind of REDD+ activities. The framework is being pilot tested in the three REDD+ Pilot sites implemented by GDANCP, FA and FiA.

To operationalize ESMF, three safeguards on the job trainings were conducted for the 3 REDD+ pilot sites under FCPF II funding. The trainings aim to provide on-site capacity building for action to REDD+ implementors at subnational level to understand and able to operationalize safeguard implementation in order to ensure that risks from REDD+ activities are mitigated or minimized at every phases of project. The first training started with REDD+ Pilot project implemented by Forestry Administration on 5-6 September 2019 at Samroang Partnership Forestry, Samroung Commune, Kravanch District, Pursat Province, participated by 21 people (6 women, 3 indigenous People) who are key representatives from Commune Council, Forestry Administration at district level, and local communities. The second training was conducted on 11-12 September 2019 at REDD+ Pilot Site at the Phnom Kulen National Park, Siem Reap, implemented by General Department of Administration for Nature Conservation and Protection participated by 21 representatives (2 women) from REDD+ Gender Group, Ministry of Environment, Provincial Department of Environment, Park Rangers, and Community Protected Area communities. The third training was organized on 17 September 2019 for REDD+ Pilot Project in Sorsdom, Siem Reap Province implemented by FiA. There were 17 people participated including Fisheries Administration staff from national subnational staff, commune council members, community fisheries and local community. As results, social and environmental risks that may occurred from the implementation of reforestation, protected area zoning, flooded forest rehabilitation, livelihood enhancement and biodigester installation activities on Indigenous people, biodiversity, gender and resettlement have been analysed and discussed with project implementors from the 3 pilots' sides and management measures to mitigate these social and environmental risks was also identified and are being implementing.

6. Progress in stakeholder consultation, participation, and disclosure of information and the Feedback Grievance and Redress Mechanism, related to this project

As part of the safeguards work, building on the progress made in 2018, the framework for safeguards information system (SIS) including SIS web portal and databased has been developed and technically reviewed and cleared by the Safeguards Technical Team, Gender and Consultation Group, and relevance

line Ministries through safeguards technical team meetings and workshops. Representative of Indigenous Peoples (IPs), Community Forestry (CF), Community Protected Area (CPA) and non-governmental organization (NGOs) also participate in the events.

In 2019, series of stakeholder consultations was conducted to ensure inclusive participation and view of stakeholders as well as to collect additional inputs to improve and validate on the final draft of the first Summary of Information (SoI). This process was leading monitored by the Safeguards Technical Team. The stakeholders were key representatives from forest institutions, relevant ministries to REDD+ implementation, gender group, local communities, and Indigenous People. They were engaged in every step of the design and analysis of Cambodia clarification, PLR assessment, social and environmental risk assessment, risk management plans, and development of information needs for the SIS. 


