Main activities and achievements:

Component 1:

- A first round of eight territorial dialogue workshops covering all the country departments- were held with the participation of 662 people, among which 32.7% were women, and 22.2% were indigenous peoples, that enabled the consolidation of REDD+ strategic orientations and actions with their respective activities.
- The REDD+ communication strategy was updated.
- Diffusion of REDD+ related information on social medias, 2,321 followers on Facebook, 182 followers on Twitter, 92 on Instagram.
- Planning activities were conducted with early REDD+ actions to strengthen capacities and consolidate alignment with the REDD+ strategy.

Component 2:

- A precision analysis of the land use coverage change dynamics map for the period 2010 2016 was conducted.
- The operations manual of the MIAQ and registry of REDD+ projects have been designed.
- Design of the thematic components of the Sustainable Forest Management Project to be implemented with funding from the Forest Investment Plan (FIP)
- An analysis of the legal and customary rights of indigenous peoples and local communities was conducted to understand the legal framework in relation to the right to property, management and use of land, forest resources and the carbon. Design of specific safeguard instruments for FIP projects: i) The Strategic Environmental and Social Assessment (SESA), ii) Environmental and Social Management Framework (ESMF), iii) Indigenous Peoples Planning Framework (IPPF)) iv) Process Framework, and v) Gender Action Plan.
- Institutional strengthening on the REDD+ strategy:
 - o INAB: plan of action designed.
 - o CONAP: legal analysis of the environmental services mechanism, definition of the scope of support to be provided to Laguna del Tigre.
 - o MARN: design of the National Information System on Climate Change (SNICC) scheme, national REDD+ registry, MIAQ, equipment.
 - o MAGA: integration of rural development planning with the national REDD+ strategy.
- Alignment of early REDD+ actions with the national REDD+ strategy:
 - o Red Pinpep: municipal assemblies, plan of action for the strengthening of the organizational structure.

The main REDD+ readiness-related challenges can be summarized as follows:

- Resolving the high uncertainty of the forest reference emission levels and forest reference levels (FREL/FRL) for the period 2006-2016.
- Detailing the analysis of deforestation and degradation drivers, including econometric and geospatial variables.
- The articulation of the 3 REDD+ phases as they are being simultaneously developed: consolidation of the National REDD+ strategy, FIP projects already designed, and REDD+ programme (ERPD) already submitted.
- The coordination with all the REDD+ stakeholders in the consolidation process (government, municipalities, REDD+ early action movers ACOFOP/ GuateCarbon, Defensores/ Lacandón Bosques para la Vida, FUNDAECO/ Costa de la Conservación, Calmecac/ Redes Locales, private sector, Alianza Nacional de Organizaciones Forestales Comunitarias, Red de Beneficiarios del PINPEP, GIMBUT)

The main REDD+ readiness-related activities and achievements to be delivered next year are summarized as follows: Component 1:

- Consolidate the national dialogue process:
 - o Two additional dialogue rounds of eight territorial dialogue workshops (16 in total) to socialize the benefit distribution mechanism, MIAQ and the REDD+ strategy 2.0.
 - o A national forum to design the indigenous peoples' roadmap for the implementation of the REDD+ strategy.
 - A national forum to socialize the REDD+ strategy 2.0.

Component 2

- First report of implementation of the national gender roadmap
- The design and operationalization of the REDD+ benefit distribution system.
- REDD+ Strategy articulation with municipal planning and early REDD+ actions.
- Safeguard instruments for the REDD+ program (ERPD): Indigenous People's Planning Framework (IPPF), Environmental and Social Framework (ESF), Stakeholders Engagement Plan (SEP), Environmental and Social Commitment Plan (ESCP), Process Framework, Resettlement Framework.
- The econometric and geospatial analysis of deforestation and degradation drivers. Submission of Version 2.0 of the National REDD+ Strategy and updated R-Package.
- Institutional strengthening on the REDD+ strategy:
 - o All GCI institutions (MARN, INAB, CONAP, MAGA: capacity development support and institutionalization support on MRV, registry, FREL/FRL, consultation and participation processes.
 - o CONAP: design of the framework for environmental services in protected areas, technical and institutional approach for Laguna del Tigre, design of the institutional strategy, equipment.
 - o INAB: support to the forest inventory (field data collection), lineaments for the compensation mechanism including carbon, pests, illegal logging; strengthening of INAB platform of beneficiaries, provision of equipment.
 - o MARN: design of the mechanism for the national Climate Change Fund, support for the design and operationalization of the SNICC, national REDD+ registry, MRV, support for the revision of environmental regulation with a focus on REDD+, provision of equipment, training of regional units on MIAO.
 - o MAGA: support for the articulation between family farming, extension and REDD+, provision of equipment.
- The alignment of early REDD+ actions with the national REDD+ strategy will be strengthened:
 - o Municipal planning in 35 municipalities (represented by 7 associations- mancomunidades) aligned with the national REDD+ strategy, community monitoring, promote the scaling up of climate adaptation model.
 - o Sierra de las Minas- Lacandón Bosques: Verification of GHG emission reduction for 2014-2017 and communication strategy designed.
 - o Redes Locales: design of Project Document (PDD), 4 management manuals, and a communication strategy.
 - o Laguna del Tigre: Analysis of GHG emission reductions approach.
 - o Costa de la Conservacion: GHG emission reduction monitoring report, Verification of GHG emission reductions for 2017-2018, legal analysis to generate proposals on registry and national lands.
 - o GuateCarbon: capacity development plan to strengthen forest concessions, analysis of contracts for concession extension, external evaluation of standing contracts, communication strategy.
 - o Red Pinpep: legal support, consolidation of organizational structure, trainings on community monitoring. Training on the forestry framework linked with the national REDD+ strategy, exchanges of experience to strengthen articulation with national REDD+ strategy.

- o Alianza Nacional de Organizaciones Forestales Comunitarias: design and implementation of a capacity development plan linked with REDD+ and forest, analysis of the Alianza's potential contribution to the implementation of the national REDD+ strategy, exchanges of experience.
- o GIREDD: design of a communication plan, exchanges of experience and field visits with policy makers to strengthen links between early REDD+ actions and the national REDD+ strategy.
- Pinpep, GIREDD and alianza: Exchanges of experience to strengthen articulation with national REDD+ strategy.

Component 3:

• The update of the forest reference emission levels and forest reference levels (FREL/FRL) for the period 2006-2016

Component 4:

- The operationalization of the MRV system.
- Capacity development activities on and implementation of community forest monitoring at territorial level in 35 municipalities of 7 associations of municipalities (mancomunidades) and 4 REDD+ early actions.

The national REDD+ Strategy includes the following activities that directly aim to conserve biodiversity: Thematic Axis 2 Deforestation> Strategic Line Protection and conservation of strategic ecosystems and natural forests > Strategic action 4 Develop mechanisms to ensure sustainability of forest resources and ecosystem services.

The REDD+ Strategy is expected to reduce forest fragmentation in areas intervened. Fragmentation and loss of productive habitat is the greatest threat in terms of loss of biodiversity and productivity. The surface of the fragments shows a clear correlation with the diversity of species that can be housed, so that fragmentation can be used as an index of biodiversity. The fragmentation index is estimated based on a multi-temporal analysis and other public geodata. An evaluation of forest fragmentation change will be performed every 5 years in areas intervened by the REDD + Strategy.

Proposed indicators to monitor the REDD+ strategy contribution to biodiversity conservation are:

- o Annual increase (%) in number of CONAP forestry incentive projects
- o Annual increase (%) in number of INAB forestry incentive projects
- o Annual increase in area (ha) of forest incentive projects of CONAP
- o Annual increase in area (ha) of forest incentive projects of INAB
- o Annual proportion of area (ha) incentivized in natural forests with native species of high conservation value with PINPEP and PROBOSQUE
- o Annual area (ha) of forest under sustainable management and area of total forests

 - 1. IDB is currently implementing the second FCPF grant, in coordination with the Government and key stakeholders (public and private sector actors, academia, indigenous peoples' organizations, NGOs, municipalities, farmers organizations, women groups among others) in order to ensure the consolidation of the Strategy (REDD+ early actions, community organizations and 35 municipalities) and its alignment within the national institutional and policy framework. To date, 50% of the total amount has been executed (US\$ 2,514,657), 97% has been committed (US\$ 4,855,051) and 3% is left available (US\$144,949). Execution details are as follows:

- 2. Regarding the first donation (US\$ 3.8 million) which was implemented by MARN, the termination process of the operation has been completed and the final execution was 90% (US\$ 3,414,839) with a remaining balance of US\$ 385,161. Currently IDB is in the process of making the necessary arrangements to use the remaining funds for the consolidation of the REDD+ strategy as follows:
 - a. US\$ 25,161.00 will be used for Component 1 "Strengthening the participation of REDD+ stakeholders" (current amount US\$ 1,044,000), to support South-South knowledge exchanges on sustainable livestock and agriculture programs under REDD+ schemes, as well as to finance socialization workshops with stakeholders regarding the proposals that will be prepared for these sectors.
 - b. US\$ 260,000.00 will be directed to Component 2 "Strengthening the linkage between the National REDD+ Strategy and the national policy and planning framework" (current amount US \$ 1,630,000), in order to: (i) prepare a proposal for emission reductions in the livestock sector aligned with the REDD+ Program, (ii) design a pilot plan for emission reductions through the use of ethanol, (iii) consultancy to support management of climate financing approval for the implementation of activities REDD+, and (iv) a consultancy to support the Inter-Agency Coordination Group (GCI) to link institutional agendas between the National REDD+ Strategy.
 - c. US\$ 100,000.00 will be used for Component 3 "Design and strengthening of the Monitoring, Reporting and Verification system at the territorial level" (current amount US\$ 1,841,000), in order to consolidate the georeferencing of the forestry incentive programs polygons, in view of the consolidation of the carbon stock baseline.
- 3. The articulation of the 3 REDD+ phases is being promoted: The preparation of the REDD+ strategy (phase 1) is well aligned with other ongoing preparation activities of phases 2 (FIP and NAMA on the efficient use of firewood) and 3 (ERPD).
