<u>Technical Committee Meetings:</u> Eleven rounds of technical Committee (TC) meetings were held during the reporting period. In general, discussion were held regarding (a) REDD+ activities that were implemented in different islands (b) management related issues about the REDD+ Project (c) Contract negotiations on MRV related issues, SESA and regarding recruitment of individual consultants for various other studies.

Participation of REDD+ Unit in the National Agriculture Week: The Department of Agriculture, Vanuatu, organized National Agriculture Week from July 16 to 20, 2018 in Santo. All Departments under the Ministry of Agriculture participated in this Agriculture Week. Local people and villagers from the Santo also participated in the Agriculture Week. REDD+ Unit also took part in the occasion. REDD+ extension materials were displayed and also explained to the people who had come to participate in the occasion.

Awareness Raising Activities on FGRM, MRV and deforestation and forest degradation, Strategy Options and Benefit sharing Mechanism: Awareness raising and also explanation, to different stakeholders were carried out pertaining to the outcome from the following studies like FGRM, Deforestation and Forest Degradation, Strategy Options and Benefits Sharing

Mechanism. Main objective was to inform the local people and other relevant stakeholders about the REDD+ readiness activities that are implemented in different islands. Seedlings were also distributed to the local for planting in their land. The dates were as follows: (a) Efate July 27, 2018 (b) Erromango Aug 6 - 10, 2018 (c) Tanna Aug 20 - 22, 2018 (d) Malekula Sept 17 - 21, 2018 and (e) Santo Sept 24 - 28, 2018.

National Forestry Week, August 2018: National Forestry Week was celebrated from August 21st to August 25th 2018. The CSO Network based on all REDD+ islands took the lead role in celebrating this activity. Besides the CSO Network the other important stakeholders like the officers from the Department of Forests, Agriculture, Fishery, livestock, Horticulture, Environment, women Groups, Youth Groups, and Provincial Administration also took active part in the celebration. The main objective of organizing this activity was to (a) create awareness about the REDD+ readiness activities in different islands (b) inculcate a sense of responsibility in planting trees in their surrounding areas including the backyards. The local people also showcased the items made out of forest products.

REDD+ Awareness Raising for Senior Officers of the Ministry of Agriculture: One day awareness raising as well as information dissemination workshop was held for the senior level officers of the Ministry of Agriculture on 13th September 2018. The senior officers were (a) Acting Director General of the Ministry of Agriculture (b) Director of Forest Department (c) Director of Agriculture Department (d) Director of Livestock Department (e) Director of Fisheries (f) Director of bio-security (g) and many other mid level officers from the above-mentioned Departments.

<u>GIZ Sponsored Study Tour for Communication Officer of REDD+ Project:</u> The REDD+ Extension and Out-reach Officer (including some other Forest Officers from the Department of Forests) took part in the study tour to Germany which was funded by GIZ. The study tour was from September 17 to 21, 2018. The participants were exposed to the forestry operations in Germany including agriculture activities, Timber industries and Forestry Research.

<u>National REDD+CSO Platform Executive Committee Meeting:</u> A one-day CSO Platform Executive Committee was convened by the REDD+ Unit on 25th October 2018. The objective was to brief the executive members of the Platform about the REDD+ activities that will be implemented in different islands by the CSO Networks.

National CSO Platform Planning Workshop: Two days planning Meeting (6th and 7th of December 2018) was conducted for the National CSO Platform Members. The aim was to develop future roadmap for the CSOs in implementing the REDD+ readiness activities more importantly the National Forest Inventory and SESA works. They also developed other activities related to REDD+ readiness program to be implemented in the coming months.

REDD+ Awareness Raising for the U-19 Vanuatu Soccer Team: One day awareness raising campaign was conducted for the U-19 Vanuatu Soccer Team. During the occasion extension materials produced by the Extension Section of the REDD+ Unit was also distributed to the players. The main was to disseminate the REDD+ key messages among the young sportsmen of the country.

Renovation of Forest Department's Offices in Erromango and Tanna: The Forest Department's Offices in Erromango and Tanna houses (a) the Regional Forest Officer Office and (b) CSO Representative Office. The Offices, in both these islands, were in dilapidated condition therefore the REDD+ Unit supported in renovating these Offices so that the concerned Officers from the Forest Department as well as the CSO Representative will have better place for working. The renovation was carried out successfully and completed on time. Renovation was done on a cost sharing basis. The materials cost was borne by the REDD+ Project and the labour cost was borne by the Forest Department. Now the Officers have better place for working.

<u>Progress on National Forest Inventory, Activity Data Generation and Establishment of National Forest Monitoring System including MRV:</u> Consultancy on National Forest Inventory (NFI), Generation of Activity Data using remote sensing method and database development was contracted to a German Consulting Firm M/S UNIQUE. The contract between UNIQUE and the REDD+ Unit Vanuatu was signed on 31st January 2019. After submitting the Inception report by the consultant a detail discussion was held in Port Vila thereafter the consultant started the work with effect from 1st April 2019. Main objective of this consultancy is to conduct national forest inventory and generate emission factor data, generate activity data on forest resources and forest cover change using remote sensing method for establishing the forest reference level, design the national forest monitoring system including the MRV and establish the database system in Vanuatu.

- ON NFI: The work on NFI started after 2 weeks refresher training, on the inventory methodology, for the crew members. The NFI work in Efate island is completed (260 sample plots measured) and the crew are working in the island of Santo.
- o On Mapping work: The main purpose of this exercise is to collect data on forest resources and forest cover and forest

cover change from all islands using the remote sensing methods to meet the IPCC Approach 3 requirement. Therefore for this purpose two weeks training was conducted by the consultant for the local GIS/RS staffs of the Forest Department. GIS Team of the Forest Department has learnt how to use Quantam GIS which is open source software used for mapping/generation of activity data. Till now, the Team has completed the pre-clarification works of NFI sample plots for 12 islands. The Team will now work on delineation of landuse.

On Database Development: Two weeks training was also conducted for the Database Officer by the UNIQUE consultant. OPEN FORIS is used which has been installed on all the local servers. The inventory data are received and uploaded in the database. The NFI field and Mapping works are expected to be completed by November 2019 as per the work plan submitted by UNIQUE.

<u>Celebration of International Day of Forests on 21st March 2019:</u> The REDD+ Unit, in collaboration with the CSO Platform and the CSO Network in the islands and Forest Department organized and celebrated the international day of the forests. This is an annual event and celebrated every year on 21st March. The main aim was to disseminate the REDD+ massages to the urban dwellers and students including the people working in government offices and also in private sectors. The day was used for planting trees in the surrounding of the offices, empty space within the municipality and schools. In Port Vila the day was celebrated in Malapoa College with the students and teachers. The activity was implemented in all five REDD+ islands with the support of the CSO Networks and Forest Department.

<u>Database Development:</u> In order to design a functional National Forest Monitoring System (NFMS) including the MRV system in the country, there was a need to assess and analyze the existing database on the forest resources available with the Forest Department and identify the requirement of data that will fulfil all requirements for establishing NFMS. With this background, the REDD+ Unit hired one Database Officer with effect from 23rd April 2019, who will be responsible for providing all necessary data and information for monitoring, reporting and verification of REDD+ activities in Vanuatu. OPEN FORIS Collect is installed and all the data received from the NFI are uploaded in this OPEN FORIS Collect and is functioning smoothly.

<u>REDD+ CSO Platform Executive Committee Meeting:</u> CSO Platform executive Meeting was held on 4th of April 2019. The aim was to apprise the members of the Platform regarding the National Forest Inventory and SESA that are implemented in the country. The Platform members were also requested to inform all the concerned stakeholders especially the villagers about the activities that are being implemented so that everybody is well informed in advance.

<u>PTAC and CSO Network Committee Workshop:</u> A Three-day Workshop was organized from 19th of March 2019 to 21st March 2019 in Malekula island for the all the PTAC Chairmen, CSO Network Members from all the REDD+ islands. Total number of participants who attended this Workshop was 21. (16 participants representing CSO Network, 3 Forestry Officials from Department of Forest and 2 participants representing REDD+ Unit). There were 5 women and 16 male participants. The aim was to introspect on the REDD+ readiness activities that were implemented in their respective jurisdiction. Identify implementation issues and recommend for future implementation smoothly.

<u>Progress on the Study of Value Chain Analysis of Non Timber Forest Products:</u> Individual Consultant (IC) has been hired to study on the value chain analysis of Non Timber Forest Products (NTFP) of Vanuatu. The main objective for commissioning this study is that the outcome from the study would be used to inform the National REDD+ Strategy development of Vanuatu. The contract, with the individual consultant has been signed on 29th of May 2019 and the inception report including the methodology and work plan was discussed on 19th of June 2019. Further work on this study will start from June 2019 and will be completed within September 2019.

<u>Progress on SESA:</u> The work on SESA has been awarded to one UK Consulting Firm M/S Climate Law and Policy. The contract was signed on 10th April 2019. The Consultant submitted the Inception Report to the REDD+ Unit on 3rd June 2019 for the work and thereafter a four-day Workshop was held from 13th and 14th of June 2019 to 17th and 18th of June 2019. Various issues especially on work plan, methodology of the study and deliverables to be submitted to client were discussed. The inception report was also shared with the World Bank Technical Team. The consultation with the stakeholders in five REDD+ islands were discussed and agreed. As per the work plan submitted by the Consultant the work will be completed by April 2020.

Awareness Raising and Information Dissemination about REDD+:

REDD+ Unit have contract with the Vanuatu Broadcasting Television Corporation (VBTC) to air the key REDD+ messages and also important announcement pertaining to REDD+ activities that are being implemented in the field. The objective is to inform all the stakeholders including the Government Offices, CSOs, and Private Sector Organizations about the REDD+ Program. To reach more rural areas in different islands Radio FM 107 is also being used for this purpose.

- 3) Complete the National Forest Inventory (NFI), mapping work to detect the landuse and landuse change in the country and generate activity data.
- 4) Establish the Database System for National Forest Monitoring System including the MRV
- 5) Complete the work on SESA and development of ESMF within April 2020.
- 6) Complete study on Value Chain Analysis of NTFP by September 2019.
- 7) Complete the development of National REDD+ Strategy Document by April 2020.
- 8) Develop R- Package and submit to the PC.

The aim for carrying out this activity is to collect/generate data on forest cover and forest cover change of different islands of Vanuatu using remote sensing method that will meet the IPCC Approach 3 requirements for spatially explicit activity data of forests. The work is being done by the GIS Section of Forest Department with the technical support of the consultant. It will produce forest cover and forest cover change maps, conduct analysis required for estimation of activity data and assessment of its accuracy. The work on collecting/generating activity data is being carried out in parallel with the forest inventory and include (a) collection and organization of remote sensing data and imagery (b) generation of forest cover and forest cover change maps (c) interpretation of remote sensing data to estimate activity data on forest cover and forest cover change for the reference period (d) conduct accuracy assessment to generate stratified area estimates.

		The activities planned to be carried out for the development of MRV system are (a) Development of a robust and transparent MRV system for monitoring and reporting REDD+ activities for estimation of emissions and removals and associated standard operating procedures (SOP) for collecting, analyzing, estimation and reporting (b) design of database and reporting and archival of data and information and (c) training and capacity building for implementing the National Fprest Monitoring System (NFMS). The aim of the national REDD+ program, of Vanuatu, is to sustain and enhance livelihood of the *ni-Vanuatu* people who are living in the rural areas. The Strategy Options study has identified many activities that were geared towards enhancing the livelihood of the common people by generating additional household income for their family. Some of the important activities which enhances livelihood of the rural people are Management of Protected Areas by involving local communities, management of non timber forest products, initiating agroforestry system by combining with more promising agriculture and horticulture activities and development of a national overarching landuse plan. The National REDD+ Strategy is yet to be developed. However action to initiate the development of National REDD+ Strategy is already underway. All such income generating schemes which will enhance livelihood of the rural people would be part of the National REDD+ Strategy. The National REDD+ Strategy document is not yet developed but biodiversity conservation has been prominently featured in the development of National Forest Monitoring System. Therefore as part of the NFMS the biodiversity information system (BIS) will be developed and will form one of the most activities of the National REDD+ Strategy. While drafting the National REDD+ Strategy, the biodiversity information system including the protocol for monitoring will form part of the National REDD+ Strategy.

The Institutions responsible for the biodiversity information and monitoring, both at national and sub-national level will be fully involved while developing the NFMS. The conservation initiatives related to convention of biological diversity already exists for Vanuatu but more work is required to be done to upgrade the capacity of the local staffs for monitoring the biodiversity.

The Forest Officials at the National level are trained and they have been initiating various activities to generate awareness about the importance of forestry in general and REDD+ program in particulars.
