Liberia RPP is highly participatory, and the implementation of the grant gained momentum towards the end after a slow start. Almost all the grant had been disbursed (\$ 30 k undisbursed). The major achievement is that the Liberia RPP has been approved by the FCPF executive committee in Oslo in June 2011., and this allows Liberia to receive additional \$ 3.4 M for the implementation of the RPP.

### **Bank Performance:**

#### Comment:

The World Bank accompanied Liberia throughout the preparation of the RPP with missions, audioconferences, teleconferences, trainings. The World Bank assisted Liberia also commenting on many early drafts of the RPP and in preparing the PPT for the informal presentation in Vietnam and the formal in Oslo. The World Bank also helped Liberia in addressing comments received by civic society. Finally the World Bank assisted Liberia with exchange of experiences with many other FCPF countries. As a result Liberia RPP was approved in Olso in June 2011 and received a lot of good comments.

## Additional Assessment

### Development / strengthening of institutions:

#### Comment:

The RPP preparation process has increased significantly the capacity of the REDD working group. REDD+ activities are managed at the advisory level by the REDD Technical Working Group (RTWG); the RTWG is a platform for all stakeholders, including other sector government agencies (FDA, Ministry of Agriculture, Ministry of Energy, Ministry of Finance,etc), civil society, development partners and the private sector. Most importantly, it reaches down through the National and County level forest forums to stakeholder and communities closer to the forest and directly affected by REDD+ issues. Based on this, the REDD TWG provides technical advice to inform and guide decisions about the program development in Liberia. Civil Society Organizations (CSOs) are represented on the RTWG and fully participated in the development of the R-PP. While Skills and Agriculture Development Services (SADS) represents CSO officially on the RTWG, the participation of Federation of Liberian Youth (FLY), Action Against Climate Change (AACC), Sustainable Development Institute (SDI) and Green Advocates (GA) gives CSO an added representation in the entire process. This was to ensure that the R-PP process captures concerns and views from diverse stakeholders. Also, in order to make the R-PP process inclusive and participatory, comments from CSOs in the initial informal submission made at the Vietnam meeting in March 2011 were integrated during the final drafting stages of the proposal.

### Mobilization of other resources:

#### Comment:

International Cooperation in Liberia's forest sector

In 2004, the Liberia Forestry Initiative (LFI) was formed to assist Liberia to reach sufficient standards of forest governance and management to enable the lifting of UN Timber Sanctions. The LFI, which was led by the US Government, included UN agencies (FAO, UNEP), bilateral partners (EU), funding institutions (World Bank), international NGOs (Environmental Law Institute, Conservation International, IUCN, Fauna & Flora International) and local NGOs (Green Advocates, Sustainable Development Initiative).

The LFI is an informal arrangement but provides a forum for consensus on development priorities and for programme coordination in the forest sector. The advent of REDD has seen a number of new initiatives by development partners which are summarized in the attached RPP.

Excellent both inside Liberia and outside with other FCPF countries.

### Client's policy / program implementation:

#### Comment:

The RPP is a Liberia document to implement policy related to reduction of emission from deforestation and degrdation. There is high GoL committment to it.

### **Efficiency:**

#### Comment:

The size of the Grant is small but delivered a lot and leveraged considerable amount of co-financing. Cost has been moderated and efficiency has been high.
