OVERVIEW

Overall Assessments

Grant Objectives:

The objective of the R-PP Formulation Installment is to assist the Recipient to formulate a Readiness Preparation Proposal (#R-PP#), on the basis of the Readiness Preparation Idea Note, following the FCPF template for the R-PP.

Overall progress from 07/01/2013 to 06/30/2014 with regard to Achieving Grant Objectives:

Comment:

Overall progress towards REDD+ Readiness has been slow progress, particularly due to delays in establishing the technical team in charge of the project (UT-REDD+). Recently, the pace has picked up with the UT-REDD fuly staffed, several analytical studies launched and consultations with stakeholders relaunched. Mozambique has enacted a national decree that institutionalized a REDD+ Technical Group (UT-REDD+), formed by representatives of MINAG, MICOA and FUNAB, which meets weekly. At the Approval of the Decree, the Council of Ministries requested the establishment of an inter-ministerial group (Comite Tecnico de Revisao) to serve as a single platform for the government to harmonize the procedures of channeling rates of exploitation of Natural resources for local communities. This group was created and is composed by the sectors of Agriculture, Fisheries, Tourism, Finance, State Administration, Mineral Resources, Planning and Development, under the coordination of the Environment sector. Despite the creation of the group, no meetings have taken place yet. The same Decree also sets out the procedures for REDD+ project approval (Decree No 102/2013). The UT-REDD+ has been promoting consultations on this decree in seven of the eleven provinces. Since May a new coordinator is in place. Regarding the National REDD+ Strategy, the UT-REDD has decided recently to hire a firm to prepare a study that will identify the drivers of deforestation and the strategic options for addressing them, as well as an analysis that will provide options for a legal and institutional framework. A firm that will prepare the Strategic Environmental and Social Analysis and the ESMF is also in the process of been hired.

Overall progress from 07/01/2013 to 06/30/2014 with regard to Implementation of Grant Financed Activities: Comment:

The implementation progress is rated moderately unsatisfactory. Disbursement has been very slow # around 5% of the total grant (US\$3.8 million) until the end of Q2 2014. The task team expects that disbursement will increase after hiring the firms that will prepare the technical studies.

Grant follow-up and structure

Description and context of Grant:

In response to the request for financial assistance made on behalf of the GoM and the decisions of the FCPF Participants Committee, an amendment to the Grant Agreement to extend the Additional Grant in the amount US\$3.6 million was signed on June 26, 2013. Following counter signature of the amendments, the Additional Grant became effective in July 2013.

Expected follow up (if any): Follow up Bank project/loan/credit/grant

Comment on follow up:

A potential ER-Program could be supported through results based finance under the BioCF or FCPF Carbon Fund. An initial estimative financial envelope is US\$ 50 million.

End Date of Last Site Visit:

Restructuring of Grant:

In January 2012, the World Bank signed a Grant Agreement with the Government of Mozambique in support of the REDD+ Readiness Project (P129413), with funds from the Forest Carbon Partnership Facility. This initial US\$200,000 grant had three disbursement categories: Goods and Consultants# services, Workshops and Training, Operating Costs.

In July 2013, an additional Grant Agreement of US\$ 3.6 million was signed between the WB and the Government of Mozambique. This additional grant supports the implementation of Mozambique#s Readiness Preparation Proposal (R-PP). The Grant Agreement, however, does not refer to any disbursement category.

The project was restructured so that a new disbursement category for #goods, training, operating costs, non-consulting

There has been a weak coordination with the MICOA MINAG department (DNTF) which is leading the MRV system; this should be strengthened. The task team has been suggesting more frequent communications among those institutions. Related to other REDD+ initiatives, especially at the regional local / provincial level, very little coordination has been occurring. The task team is working closely with MITUR and other development partners to expand the REDD+ process to other provinces of the country.

- 3. Describe progress in addressing key capacity issues (implementation, technical, financial management, procurement) related to this Grant.

The task team has been providing training on safeguards, procurement, and financial issues to the UT-REDD team on a daily basis. An in-depth safeguards training to the UT-REDD team (MICOA and MINAG) was organized in August, 2014. The task team has been having skype meetings with the REDD+ coordinator on a monthly basis.

The firm that will prepare the SESA/ESMF was planned to be hired in August, however there has been some delays.
