Re: Amendment to the Letter of Intent between the International Bank for Reconstruction and Development, acting as the trustee of the Carbon Fund of the Forest Carbon Partnership Facility, and the Republic of Cote d'Ivoire, represented by the Ministry of Health, Environment and Sustainable Development, dated November 18, 2015 with respect to the 'Emission Reductions Program in the Tai National Park Area' in Cote d'Ivoire

Excellency:

We refer to the Letter of Intent between the International Bank for Reconstruction and Development ("IBRD") acting as the trustee ("Trustee") of the Carbon Fund of the Forest Carbon Partnership Facility ("Carbon Fund") and the Republic of Cote d'Ivoire ("Program Entity"), represented by the Ministry of Health, Environment and Sustainable Development, (together referred to as "Parties") dated November 18, 2015 ("Letter of Intent") with respect to the 'Emission Reductions Program in the Tai National Park Area' in Cote d'Ivoire. Capitalized terms used in this amendment letter shall have the same meaning ascribed to them in the Letter of Intent.

- The Parties agree to herewith amend the Letter of Intent as follows:
 - (a) The Exclusivity Period specified in Section 3.1 of the Letter of Intent shall be extended from twenty four (24) months to forty two (42) months.
 - (b) Section 7.2 of the Letter of Intent shall be deleted in its entirety and replaced as follows:
 - "7.2 If the ERPA Negotiation Period has not started within thirty six (36) months from the date of this Letter of Intent, the Trustee may, at its sole and absolute discretion, either terminate this Letter of Intent and the understandings it provides or extend the deadline provided in this Clause 7.2."
- 2. In the event that the participants of the Carbon Fund have not approved the proposed extension of the Exclusivity Period (see above para 1.(a)) by February 3, 2018, this amendment letter shall be deemed null and void and the Letter of Intent shall terminate with immediate effect. In the event that the participants of the Carbon Fund only approve an extension of the Exclusivity Period that is shorter than the extension provided for above in para. 1.(a), the Parties shall further amend the Letter of Intent to reflect such approved shorter extension period. The Trustee shall promptly notify the Program Entity of the corresponding decision made by the participants of the Carbon Fund.
- Unless expressly provided for otherwise in this amendment letter, all other provisions of the Letter of Intent shall remain unchanged and in full force and effect.
