Background: Liberia reporting framework has been developed following the structure of the FCPF Monitoring and Evaluation Framework, its logical framework and Performance Measurement Framework (PMF), so as to facilitate and systematize the data analysis. This annual country report provides the FCPF's Facility Management Team (FMT) with indications of Liberia's REDD+ progress towards achieving its readiness activities and the implementation of its Emission Reductions programs overtime. In this manner, data are easily consolidated and provide indications on the level of achievement of the FCPF output, outcome and impact indicators as defined in the FCPF M&E Framework.

Report preparation: This submitted report is drawn upon Liberia's M&E system for REDD + (component 6 of R-PP) and is prepared in consultation with members of REDD+ Technical Working Group (RTWG) and the SESA Working Group, with inputs from other stakeholders including CSOs and local communities.

Reporting schedule: This annual progress country report covers the period August 2015 to August 2016. The report is based on a self-assessment of progress.

1. SUMMARY OF REPORT

This section provides a short description of activities financed by the FCPF. The below information summarizes progress, key achievements with a focus on higher level results and important issues/problems that arose during the reporting period.

SUMMARY

- REDD+ National Stakeholders Consultation: Consistent with the consultant deliverables to ensure nation-wide stakeholders buy-in into the REDD+ National Strategy development, the RIU in collaboration with LTS-NIRAS supported the organization and facilitation of a one-day National Stakeholder Consultation workshop in Monrovia on July 14th, 2016.
 - Number of participants The REDD+ National Stakeholders Consultation brought together over Seventy-five (75) participants representing government institutions, private sector institutions, local and international organizations, CSOs, youth, women group, media, local communities and academia)
 - Purpose / Overview The REDD+ National Consultation Workshop aimed to achieve the following objectives:
 - To present the draft REDD+ Strategy text to national stakeholders and solicit technical inputs to the documents;
 - To present the REDD+ policy, legal and institutional framework for implementation;
 - To identify gaps related to benefit sharing, sectorial coordination, and additional measures to mainstream REDD+ implementation into wider national developmental goals
 - Achievements/Outcomes: By the end of the national consultation,

- FDA-RIU and LTS-NIRAS had obtained substantial technical inputs from stakeholders through a highly interactive process.
- Stakeholders agreed that the REDD+ Strategy and its annexes were at an appreciable level and a "working document" pending validation in September 2016.
- 2. TFA 2020 Africa Oil Palm Initiative -2nd Liberia Country Workshop and Capacity Strengthening for Stakeholders: In collaboration with the Ministry of Agriculture and national stakeholders, the REDD+ Implementation Unit with funding from Proforest and FCPF organized and facilitated the 2nd National Oil Palm Initiative and provide Capacity Strengthening for national stakeholders.
 - Number of participants Over 120 participants representing various relevant government ministries, agencies and commissions, private sector, donors local and international organizations, Civil Society Organizations, media, academia, youth, women groups and local communities,
 - Purpose / Overview The initiative was organized around the following objectives:
 - To enhance stakeholders' knowledge on national roadmap for achieving "Zero-Net-Deforestation" in the Forestry and Agriculture sectors;
 - To develop a national framework for implementation of the TFA 2020 in Liberia;
 - To introduce new tools such as High Carbon Stock (HCS), High Conservation Value (HCV) and Free, Prior Informed Consent (FPIC) and start exploring their meaning in the Liberia context;
 - To establish a roadmap in the lead to the signing of a Regional Accord at the Conference Of Parties (COP22) in Marrakesh aimed at curbing deforestation and promoting sustainable supply chain;
 - To identify partners and resources necessary for implementation of actions under Liberia's nine (9) guiding principles for sustainable oil palm production.
 - Achievements/Outcomes: At the end of the initiative:
 - Stakeholders agreed on a viable framework for implementing sustainable oil palm production through a "zero-net-deforestation" mechanism in Liberia.
 - Stakeholders agreed on the development of a Standard-Operating-Procedure (SOP) template for applying FPIC in Liberia.
 - Stakeholders agreed on a draft- template for the drafting of the Regional Accord and a regional conference to take in Cote d' Ivoire in October 2016.
 - Resources were identified through stakeholders with funding to support specific actions to achieve the nine (9) guiding principles
- 3. Strategic Environmental and Social Assessment (SESA) Regional and National Validation Workshop: During the period in review, the FDA-RIU and EPA in collaboration TetraTech, organized and facilitated six (6) regional consultations (from November 3 December 4, 2015) on the findings from the case studies and the outcomes from the community consultations. This process was followed by a two-day national validation workshop from February 9-10, 2016 in Monrovia.
 - Numbers of participants The estimated total number of participants at the SESA regional consultations was two-hundred forty (240) persons representing diverse interest groups across various sectors. The SESA National Validation exercise succeeded in creating a platform for participation of over Seventy (70) stakeholders representing national and subnational government institutions and private sector, local and international organizations, CSOs, youth, women group, media, local communities and academia.
 - Purpose / Overview The SESA national validation exercise was organized around the following objectives:
 - To present the SESA case studies findings and outcomes from the community consultations;
 - To agree on SESA priorities with stakeholders;
 - To review and validate the SESA priorities;
 - Achievements/Outcomes: By the end of the regional consultations and national validation exercises,
 - Government of Liberia obtained substantial feedback and technical inputs from stakeholders on

- environmental and social issues relative to sustainable forest management;
- Government of Liberia now has Final SESA priority report;
- 4. Environmental Social Management Framework (ESMF) Consultations: As part of additional activities under SESA, the FDA, EPA and Tetra Tech organized and held six (6) regional cluster consultations in *Fish Town*, River Gee for (Grand Kru, River Gee and Maryland Counties); Zwedru, Grand Gedeh for (Sinoe and Grand Gedeh Counties); Gbarnga, Bong for (Nimba, Margibi and Bong Counties); Robertsport, Grand Cape Mount for (Bomi, Gbarpolu and Grand Cape Mount Counties); Buchannan, Grand Bassa for (Rivercess, and Grand Bassa counties) and finally Voinjama, Lofa County, on the draft ESMF report. The number of participants for these regional consultations was approximately two-hundred-forty (240) persons. Following regional consultations, a two-day national consultation which brought together eighty-nine (89) participants was held in Monrovia to validate the draft ESMF.
 - Purpose / Overview The consultations was:
 - To present the impacts for validation and to solicit feedback on the issues that would affect the propose framework to mitigate these impacts.
 - To provide critical opportunities for communities and county level stakeholders to review the REDD+ strategy options being considered and to make inputs that would be taken into account during revisions.
 - Achievements/Outcomes: By the end of the regional consultations and national validation exercises, Government of Liberia obtained substantial feedback and technical inputs from stakeholders on the draft ESMF.
- 5. Smallholder Productivity and Forest Protection Program Launch: To facilitate initiatives aimed at reducing deforestation and degradation in the forest and agriculture sector; and foster Liberia's goal of pursuing "zeronet-deforestation", the FDA in collaboration with IDH Sustainable Trade and relevant stakeholders organized a smallholder productivity and forest production symposium and program launch.
 - Number of participants— Sixty (60) Participants was drawn from various government ministries and agencies, private sector, local and international organizations, CSOs, youth, women group, media, local communities and academia.
 - Purpose / Overview To launch the Smallholder Productivity and Forest Protection Program to help Liberia counter the negative impacts of deforestation and forest degradation.
 - Achievements/Outcomes: Stakeholders agreed on the urgency and processes that should lead to smallholder Productivity and Forest Protection Program. Roadmap for the process was developed.
- **6. National Capacity Strengthening Initiative for Forest and Land Cover Mapping:** To fulfill commitments under the capacity strengthening aspect of the contract, the FDA-RIU in collaboration with Metria-GeoVille conducted a five-day national capacity strengthening exercise from May 16-20, 2016.
 - **Number of participants** Forty-five (45) Participants was drawn from various government ministries and agencies, local and international organizations, CSOs and academia.
 - Purpose / Overview To conduct training for the staff of the Forestry Development Authority (FDA), LISGIS, Environmental Protection Agency and other relevant stakeholders on digital mapping of forest and land cover and its changes using satellite images and GIS.
 - Achievements/Outcomes: By the end of the training,
 - Stakeholders understood the usage and application of Quantum GIS (QGIS) in forest monitoring.
 - Stakeholders performed hand-on practical exercises on how to perform validation of forest and land cover map data, including accuracy in reporting in QGIS.
- 7. National Capacity Strengthening initiative for Liberia's Reference Emission Levels and QGIS: To fulfill commitments under the capacity strengthening aspect of the contract, the FDA-RIU in collaboration with Winrock International-Conservation International conducted a three-day national capacity strengthening training from April 16-18, 2016.

- **Number of participants** Forty (40) Participants was drawn from various government ministries and agencies, local and international organizations, CSOs and academia.
- Purpose / Overview —To strengthen the capacity within Liberia to establish and maintain a REDD+ Reference Level.
- Achievements/Outcomes: By the end of the training,
 - Participants gained an understanding of the components of Reference Level (RL) creation
 - Participants understood technical steps required to create RL
 - Participants understood the types of data that must be developed to create activity data and emission factors
 - Participants gained understanding on the implications of using global, regional, and countryspecific data.
- 8. National Public Disclosure: Environmental Social Management Framework (ESMF), Process Framework (PF) and Integrated Safeguards Data Sheet (ISDS) (June 2016): To ensure the dissemination of these safeguard report for the LFSP, the FDA-RIU conducted a regional tour across three landscapes to distribute the final ESMF, PF and ISDS.
 - Purpose / Overview —To facilitate the full disclosure of the LFSP final ESMF, PF and ISDS within the targeted landscapes.
 - Achievements/Outcomes: By the end of the disclosure,
 - All counties within the targeted landscapes were fully aware of the REDD+ process and the environmental and social implications of the LFSP.
- **9.** Liberia Forest Sector Project: National Stakeholder Workshop (Dec. 9th, 2015): To conclude the consultation processes on the LFSP, the FDA along with the World Bank convened a national workshop in Monrovia to enable stakeholders review and validate their feedback.
 - **Number of participants** Eighty (80) Participants was drawn from various government ministries and agencies, local and international organizations, CSOs and academia.
 - Purpose / Overview –To facilitate the review and validation of stakeholders' feedback into the LFSP Project Appraisal Document.
 - Achievements/Outcomes: By the end of the national consultation workshop, the FDA produced the LFSP Project Appraisal Document.
- 10. Developing a Roadmap for Liberia's National REDD+ Measuring, Reporting and Verification (MRV) Framework: In order to plan activities for developing a roadmap to establish a national MRV system for REDD+ in Liberia, the FDA in collaboration with Wageningen University organized a one-day workshop on October 26, 2015.
 - **Number of participants** Ninety-four (94) Participants was drawn from various government ministries and agencies, local and international organizations, CSOs and academia.
 - Purpose / Overview —To produce a participatory and achievable roadmap outlining how an MRV system for REDD+ can be developed in Liberia; a roadmap that will serve both as a basis for capacity development when implementing Liberia's R-PP and as an example of MRV systems for other sectors within Liberia's land management strategy.
 - Achievements/Outcomes: By the end of the workshop, a participatory and implementable MRV Roadmap was produced.
- **11.** National Stakeholder Consultation to Update EXPAN's ESMF and PF for implementation of Liberia Forest Sector Project (LFSP): The FDA and EPA in collaboration with Samuel Kwabena Nketiah (SAL Consult) conducted a one-day national workshop in Kakata, Margibi County on September 3, 2015.
 - **Number of participants** Fifty (50) Participants was drawn from various government ministries and agencies, local and international organizations, CSOs, women group, youth group and academia.
 - Purpose / Overview –To update the EXPAN's ESMF and PF for implementation by the LFSP

- Achievements/Outcomes: By the end of the workshop,
 - The consultant obtained feedback and inputs from stakeholders;
 - The consultant produced an updated ESMF and PF for the LFSP
- **12.** National Preparatory Workshop (Sept 16, 2015) and Regional Validation workshop for the Liberia Forest Sector Project (October 21, 2015): The FDA organized a national preparatory workshop and three regional workshops in the targeted landscapes for the implementation of the LFSP.
 - Numbers of participants Seventy-five (75) and One hundred and fifty-five (155) participants
 respectively were drawn from various government ministries and agencies, local and international
 organizations, CSOs, women group, youth group and academia.
 - **Purpose / Overview** —To raise the profile and sensitize the general public about the LFSP and key issues surrounding sustainable forest management in Liberia.
 - Achievements/Outcomes: By the end of the workshops, participants became aware of the key components, main issues and expected results of the project.
- **13. National Forest Definition Workshop:** In the quest to improve management regimes of forests in Liberia and foster the national REDD+ Agenda. The FDA led national and international partners in the development of national definition of its forest estate. This initiative was held in Voinjama City, Lofa County from January 25th 29th 2016.
 - Number of participants More than one-hundred twenty-five (125) participants representing government institutions, private sector, local and international organizations, Civil Society and Community Based Organizations, media, local communities and academia gathered to provide inputs to the national definition for forest.
 - Purpose / Overview Define forest in the Liberian context considering the Food and Agriculture Organization (FAO) definition.
 - Achievements/Outcomes: Stakeholders agreed on the perimeters for defining forest in Liberia to include the following:
 30% Minimum Forest Cover

30% Minimum Forest Cover 5 meter minimum height 1ha minimum area

14. Revamping / revitalization of the National Climate Change Steering Committee (NCCSC) is currently on-going

- National Climate Change Steering Committee Policy briefing note for members of the NCCSC prepared and distributed
- Purpose / Overview To present the NCCSC as the highest nationally recognized platform for coordinating all adaptation and mitigation responses to climate change in Liberia. The NCCSC serves to ensure that the Government of Liberia (GoL) mainstreams climate change resilience planning into all sectors as part of its economic development strategy- the Agenda for Transformation (AfT) and the achievement of the Sustainable Development Goals (SDGs) of the United Nations. With Climate change planning being crucial to national development, it is essential that all Ministries, Agencies and State-Owned-Enterprises, the private sector and civil society understand and take into account their different roles in harnessing institutional responses to address climate change at both the national and subnational levels
- Achievements/Outcomes The President of the Republic is in the process of designating a nominee to serve as chairperson of the NCCSC who will coordinate national responses to climate change in the following sectors: Health, Forestry, Environment, Agriculture, Energy, Public Works, and Mining, etc.
- Reviewed and revised the TOR of the NCCSC awaiting the approval of the reconstitute NCCSC. Budget for the effective functioning of the NCCSC secured under the FCPF additional funding.

15. PCI Media Impact - Fauna & Flora International hired to develop Liberia's REDD+ Communication Strategy:

In order to inform the communication strategy six (6) counties forums were held by the communication

team.

- The consultant is currently preparing progress report 3 (three). Upon the acceptance of the third progress report the consultant will now prepare the final national REDD+ communication strategy for Liberia.
 - Currently the firms are enhancing the FDA and EPA websites to ensure that information regarding REDD+ activities will be prominently featured. The sites are meant to be a first tier clearing house of information on the program, providing resources and in-depth knowledge for a diversity of audiences and a springboard towards services within the national, regional and local contexts.
 - Production of quarterly newsletters for stakeholders and decision makers
 - Production of REDD+ Info-Graphic Brochure
 - A REDD+ video and song were also produced by the team
 - Production of jingles and dramas
 - Bill boards and stickers

16. LTS Niras hired to develop Liberia REDD+ Strategy

- The REDD+ National Stakeholders Consultation brought together over Seventy-five (75) participants representing government institutions, private sector institutions, local and international organizations, CSOs, youth, women group, media, local communities and academia)
- The final report on the development of Liberia's National REDD+ Strategy is expected by October 10, 2016.

17. WINROCK International and CI hired to develop Liberia Reference Emission Level (REL) / Reference Level (RL)

- Purpose / Overview To fulfill commitments under the capacity strengthening aspect of the contract, the FDA-RIU in collaboration with Winrock International-Conservation International conducted a threeday national capacity strengthening training from April 16-18, 2016.

- The final report from this consultant is expected by the September 30, 2016.

SESA report is also being finalized. It is expected that that both final reports will be deliver to the Government of Liberia through the Environmental Protection Agency by September 15, 2016.

- **22. Forestry Sector Working Group (Quarterly)** The Forestry Sector Working Group is a platform comprising of Donors, INGOS, GoL, UNMIL and relevant partners working in the forestry sector. The objective of the quarterly briefings is to update and inform members on developments and initiatives unfolding in the sector and how to synergize various interventions.

<u>South – South Exchange</u>

- 1. Two (2) Persons participated in a Regional workshop in Accra, Ghana on zero net deforestation in the supply chain organized by TFA 2020 and the Government of Ghana
- 2. Two (2) staff from the RIU participated in a Regional workshop in Kumasi, Ghana on Forest Biomass Assessment and Data Analysis from February 15-19, 2016.
- 3. One (1) staff participated in the Regional South-South Exchange Africa annual meeting of REDD+ National Coordinators held in Naivasha, Kenya
- 4. Two (2) staff of the RIU participated in the Africa Regional Training Course of the REDD+ Academy in Calabar, Nigeria from 28th October to 5th November 2015.

Important issues/problems that arose during the reporting period

- **1.** National Recovery-Post Ebola: Consultancies awarded under the current phase of the project have been slow in meeting schedule delivery of products and services post Ebola. Time required for replacing key staff that moved on due to the Ebola epidemic significantly affected key deadlines.
- **2.** <u>Rebuilding National Momentum for Sustainable forest Management:</u> Post Ebola resulted in the readjustment of sectorial priorities both at the subnational and national levels. Early Post Ebola, stakeholder consultations in the forest sector were significantly affected due to health advice on large gathering.
- 3. <u>Continual National Technical Expertise deficits:</u> Liberia still lacks full technical expertise in key areas within the forest sector. Post Ebola has seen mass exodus of technicians for better paying jobs, thus resulting into deficits within the sector. The remaining stakeholders, while available, lack a rounded approach and input on key issues. This has impeded the level of stakeholders' inputs to technical documents and issues in the forest and natural resource management sector.
- **4.** <u>Information and data management:</u> Liberia's forest sector lacks comprehensive and viable infrastructure and human capacity for data storage and management. Efforts to manage and store data within the sector have been in an ad-hoc manner. Overtime, this has resulted to several reports and data being lost due to the absence of a viable platform for data management infrastructure.
- 5. Balancing stakeholders' immediate expectation against project scope: REDD+ is still a very new concept to sustainable forest management in Liberia. It is a radical shift from 'business-as-usual' to a more transparent and participatory approach to forest governance and equitable benefit sharing of natural resources. REDD+ is expected to facilitate community and stakeholders stewardship. However, interpreting the concepts of 'benefits' and the processes for reaching "equitable-benefit-distribution" under the current REDD+ Readiness Phase has been a challenge. FDA and its partners are sustaining initiatives to inform communities and stakeholders appropriately in an effort to provide understanding of responsibilities, development and testing of viable and equitable mechanisms for benefit distribution, conflict management and grievance redress processes.

According to national institutional arrangements within Liberia's R-PP, several platforms have been created to ensure stakeholders participation in the processes leading to decision making in REDD+ and natural resource management. These are consistent with the National Forestry Reform Law of 2006 and other national policy and legal instruments.

Liberia's REDD+ decision making platforms and decision making processes include:

- 1. REDD+ Technical Working Group: Stakeholders in this platform are consulted periodically and function in providing technical oversight and performing advisory role to all national REDD+ processes. Its composition includes but not limited to:
 - a. Civil Society Organizations
 - b. Local Non-Governmental Organizations
 - c. International Non-Governmental Organizations
 - d. Academia
 - e. Media
 - f. Donors/ Development partners
 - g. Private Sector Actors
 - h. Government Institutions
 - i. Representatives of Communities and Community Based Organizations

- **4. Oil Palm Sector Technical Working:** In an effort to coordinate "zero-net-deforestation" and sustainable tree crop production in the agriculture sector, this platform functions in providing

Frequency: Quarterly

The REDD+ Technical Working Group and the SESA Working Group have separate quarterly meetings to discuss and provide guidance to the REDD Implementation Unit (RIU). Emergency meetings are held to discuss urgent issues arising prior to the schedule quarterly meetings.

The REDD+ Technical Working Group – REDD+ activities at the consultative, policy and advisory level are managed by the REDD Technical Working Group – REDD+ Policy Coordinator

Meetings are held as needed to review and approve reports from consultants in accordance with the consultants' term of reference and required deliveries.

All reports from the consultants are reviewed and approved by the RTWG and SESA Working Groups.

Examples of resources made available to enable active participation of IPs , CSOs and local communities in national REDD+ readiness.

The REDD Implementation Unit provides regular briefings and updates to CSOs and key stakeholders. Costs including (transportation reimbursement, refreshment and stationeries) are covered by the RIU for various meetings, workshops and activities related to the ongoing REDD+ process in Liberia.

Please describe these policy reforms:

- ✓ National Climate Change Policy, Strategy and Plan The policy is being developed under the guidance of the Environmental Protection Agency. It will enable better coordination of climate change work in Liberia and provide opportunity for cooperation and collaboration between the Government and people of Liberia as well as with development partners, international and regional institution, and inter-governmental organization.
- ✓ Wildlife Law deals with the sustainable management of wildlife and efficient management of Protected Areas
- ✓ The Act to establish the Gola Forest National Park will be an addition to the Protected Area Network of Liberia. This will be a sufficient contribution to Liberia's vision of putting 30% (1.5 million hectares) of our reminding forest estate under conservation.
- ✓ Land Rights Law will in effect turn over the land to local communities.

Design of national REDD+ Strategies addresses indicators for enhancement of livelihoods of local communities and for biodiversity conservation (FCPF M&E Framework Indicator 3.B.):

Liberia is in the process of finalizing its National REDD Strategy. The Community Forestry Department at the Forestry Development Authority has assisted local and forest depended communities through the CHYAO Project in developing income generating enterprises while sustainably managing the forest which the local communities utilize.

This was done through the facilitation of small scale and community based natural resource based (including forest and non-forest products) enterprises that have production or process element that gainfully employs youth in particular to reduce their reliance on unsustainable forest resource use.

In additional to the CHYAO Project, Conservation International in partnership with Arcelor Mittal Biodiversity Conservation Program and FDA have started to implement phases for piloting Conservation Agreement (feasible assessments, community engagements and negotiation, design and delivery of benefit packages) in eight (8) communities around the East Nimba Nature Reserve to ensure its protection and livelihood development for local communities. The Conservation Agreement initiative is expected to impact 225 farmers and 53 hunters directly in Nimba County around the East Nimba Nature Reserve.

FFI with funding from Norad have launched the first REDD+ pilot project in Wonegizi, Lofa county. It is expected that this pilot site will address livelihood, benefit sharing, capacity building of forest dependent people. The project is also supporting institutional policy and legal framework, governance and natural resource management at the jurisdictional level with the intent to inform the national process.

A National Biodiversity Offset Scheme: A Road Map for Liberia's Mining Sector was published in March 2015. This study took a look at proposed approaches in establishing National Biodiversity Offset Scheme whilst at the same time addressing the Rights and Interest of landowners and local communities who are heavily dependent on forests for their livelihoods and ecosystem service.

Progress made during the reporting period in developing the country Readiness Package:

Liberia made substantial progress regarding the Readiness Package of the (FCPF M& E Framework). Some milestones were met as it relates to the Readiness Package:

- ✓ The SESA draft final report has been developed, consulted on and nationally validated. The
 report incorporating stakeholders' feedback is currently being finalized by Tetra Tech ARD.
 The Government of Liberia expects to receive the final SESA report by September 15, 2016.
- ✓ The draft final ESMF report has being developed, consulted on and nationally validated. The report incorporating stakeholders' feedback is currently being finalized by Tetra Tech ARD. The Government of Liberia expects to receive the final SESA report by September 15, 2016.
- ✓ The Forestry Development Authority (FDA), after consultation and inputs from stakeholders, has received from Metria GeoVille, the Forest and Land Cover Maps of Liberia. In addition, FDA in collaboration with Metria GeoVille conducted a national capacity strengthening initiative in GIS and forest mapping and monitoring.
- ✓ Liberia National REDD+ Strategy currently being developed by LTS Niras is near final completion. During the period in review, progress made under this task has been consistent with inputs from SESA and all the other components of the Readiness Preparation Package as set forth by the FCPF. The final strategy has been nationally consulted on and LTS Niras is currently incorporating stakeholders' inputs thereafter which a national validation will be held on September 15, 2016.
- ✓ WINROCK International and Conservation International have submitted to the Forestry Development Authority (FDA), the first final draft report on Liberia's Reference Emissions Level. Based on national stakeholders' feedback and inputs, WINROCK International and Conservation International are currently revising the draft final report for submission to the FDA on September 30, 2016. WINROCK have assisted the FDA and LISGIS in national capacity strengthening initiatives related to GIS, remote sensing and reference emissions tracking.
- ✓ PCI Media and Fauna and Flora International have worked closely with stakeholders to develop a REDD+ Communication Strategy for Liberia. Additionally, to inform the REDD+ Communication Strategy, PCI and FFI facilitated subnational fora in six counties to create awareness, sensitization and obtain inputs on REDD+ and sustainable forest management. To date, PCI Media and FFI are currently facilitating the rollout of products (billboards, stickers, jingles, songs, dramas and videos) across Liberia.

4. ISSUES, CHALLENGES AND RISKS

- 1. <u>National Recovery-Post Ebola:</u> Consultancies awarded under the current phase of the project have been slow in meeting schedule delivery of products and services post Ebola. Time required for replacing key staff that moved on due to the Ebola epidemic significantly affected key deadlines.
- **2.** Rebuilding National Momentum for Sustainable forest Management: Post Ebola resulted in the readjustment of sectorial priorities both at the subnational and national levels. Early Post Ebola, stakeholder consultations in the forest sector were significantly affected due to health advice on large gathering.
- **3.** <u>Continual National Technical Expertise deficits:</u> Liberia still lacks full technical expertise in key areas within the forest sector. Post Ebola has seen mass exodus of technicians for better paying jobs, thus resulting into deficits within the sector. The remaining stakeholders, while available, lack a rounded approach and input on key issues. This has impeded the level of stakeholders' inputs to technical documents and issues in the forest and natural resource management sector.
- **4.** <u>Information and data management:</u> Liberia's forest sector lacks comprehensive and viable infrastructure and human capacity for data storage and management. Efforts to manage and store data within the sector have been in an ad-hoc manner. Overtime, this has resulted to several reports and data being lost due to the absence of a viable platform for data management infrastructure.
- 5. Balancing stakeholders' immediate expectation against project scope: REDD+ is still a very new concept to sustainable forest management in Liberia. It is a radical shift from 'business-as-usual' to a more transparent and participatory approach to forest governance and equitable benefit sharing of natural resources. REDD+ is expected to facilitate community and stakeholders stewardship. However, interpreting the concepts of 'benefits' and the processes for reaching "equitable-benefit-distribution" under the current REDD+ Readiness Phase has been a challenge. FDA and its partners are sustaining initiatives to inform communities and stakeholders appropriately in an effort to provide understanding of responsibilities, development and testing of viable and equitable mechanisms for benefit distribution, conflict management and grievance redress processes.

- ✓ Mining Act (2014 draft) Section 6 of the draft Mining Act deals with the reconciliation of competing land uses, and states that the "Minister must engage in consultation with other relevant Ministers and Government agencies to design and implement an integrated system of land use planning to evaluate competing land use options to address and resolve existing conflicting land uses involving mining operations and mining titles and potential future conflicting land uses.
- ✓ Mining Act (2014) Section 144 (Protected Areas) states that certain areas, such as a sacred ground or wildlife sanctuary, may be protected from mining. The section dealing with environmental protection (163) states that "In deciding whether or not to grant a mineral title, the Minister must take into account the need to conserve the natural resources in or on land over which the mineral title is sought, or in or on neighbouring land."
