
COUNTRY PROFILE






Key Achievement of project

- Signed 15-yeaar agreement between CF and FA Cantonment;
- measured CO2 with 8.2 MtCO2 in 30-year (2008-2038);
- Verified by 3rd party from 2008-2012 with 0.3 MtCO2;
- Registered with VCS and CCBA, got Gold standard
- Consulted with partners to develop 30-year workplan;
- Supporting from Cambodia government, allow FA sell carbon credit at least 5USD/tCO2 and maximize benefit from carbon sell go into community.

The Experiences link to National Strategy

- Land tenure and Forest management: 15-yeaar agreement between CF and FA Cantonment and renewable 15-year;
- Community right: recognize the customary user right of local communities and indigenous people;
- Private sector: technical support from TGC and SNR;
- Benefit sharing: Gov. decided that the maximize benefit from carbon sell go into community.



CHALLENGES

- B Lack of capacity building for government officers;
- B Lack of REDD+ awareness raising and Capacity building to local community and local authority;
- B Lack of fund to support field implementation;
- increase Immigrant people;
- Illegal cutting and encroachment;
- Border conflict still not yet solved;
- 8 Carbon market is not clear.
