### **OVERVIEW**

#### **Operation objectives:**

The main objective of this operation is to support the Government of Guatemala (GoG) to prepare the National Strategy for Emission Reduction of green house gases (GHG) from deforestation and forest degradation (REDD+).

## Overall progress from 01-01 2015 to 31-12-2015 with regard to achieving operation objectives

#### • Component 1:

- National readiness management arrangements through existing coordination agencies have been strengthened, with the participation of various governmental and civil society bodies and other stakeholders that are significantly affected by REDD+.
- O Guatemala has set up multi-sector coordination mechanisms to do the following: jointly manage the execution of FCPF-financed activities and coordinate complementary support from other international partners; coordinate the proposed activities for the preparation of the Strategy and its integration with the political and legal framework of forestry and other relevant sectors; and organize the exchange and dissemination of information with stakeholders.

#### • Component 2:

The REDD+ strategy options proposed are based on the experience of more than 25 year of forestry management and are supported by several policy instruments such the Forestry Law, Protected Areas Law, amognst others. Bidding process is being done for the analisys for the evaluation of land use, the factors causing change in land use, forest legislation, policies, and management.

#### Component 3:

The reference emissions scenarios are expected to be finished in July 2016. This is being done
within GIMBUT, who are receiving technical assistance from Winrock International
under USAID/CNCG

#### • Component 4:

- It has been hired the consulting firm for the design of the national MRV system which includes monitoring and information of GHG emissions, multiple benefits, other impacts, management and safeguards
- o National MRV systm will be based on existing platforms used by GCI for information exchange

Overall progress from 01-01 2015 to 31-12-2015 with regard to implementation of grant financed activities

Of the total FCPF grant of \$3.8 million, IDB has made three disbursements amounting to \$865,847.55. To date, the country has committed \$1,148,934, about 53% of total grant (\$2,014,781), leaving a balance of \$2,651,066 of available funds.

In 2015 the Execution Unit has been strengthened to expedite the implementation of the operation: It has been hired an administrative-financing assistant and a procurement assistant.

In process the devolpment of the following consultancies: (a) Elaboration of Systematizing the policy framework AND forest governance, (b) Elaboration of FGRM, SESA and ESMF, (c) Design of the national MRV system (of GHG emissions, multiple benefits, other impacts, management and safeguards.

The process of actualization of ToRs has concluded. New ToRs have been written for actitivies to support the readiness phase, for example, the initial phase of PROBOSQUE Law operationalization. From this date, ToRs and products of the readiness phase will include gender considerations.

Eleven GIS technicians have been rehired to continue the support to the GIS Units of GCI in charge of the elaboration of the national reference emission sceanrios within the GIMBUT group (formed by GCI through is GIS Units and academia).

#### Planned activities and achieved milestones:

#### **Component 1 Organization and Consultation:**

#### **Sub-component 1a. National REDD+ Readiness Arrangements:**

- The national REDD+ process is being led by the Interagency Coordination Group (GCI, formed by the Ministry of Environment and Natural Resources –MARN-, the Ministry of Agriculture Livestock and Food Security –MAGA-, National Council for Protected Areas –CONAP- and the National Forestry Institution –INAB-), both political and technical level.
- It has continued the coordination process with strategic partners to complement activities for the readiness phase (partners like USAID –CNCG and PRCC proyects-, UICN, PNUD and FAO)
- From the total FCPF funds (US\$3.8 M), 53% are committed.

#### **Sub-component 1b. Consultation, participation and outreach:**

- Capacity building and socialization activities performed with multi-sector coordination mechanisms and cross-sector collaboration
- Terms of reference have been actualized and some already includes gender considerations, for example, the national consultation and participation process
- Thorough IDB has started the bidding process for the national consultation and participation process

#### Component 2 REDD+ Strategy Preparation:

Sub-component 2a. Assessment of land use, land-use change dirvers, forest law, policy and governance:

- Terms of reference (ToRs) have been actualized for: (a) the Assessment of Land Use, Land-Use Change Drivers, Forest Law, Policy and Governance;
- Identification of aproximately 30 policy instruments which support REDD+ activities

#### **Sub-component 2b. REDD+ strategy options:**

- With the recent approbal of PROBOSQUE Law, through FCPF funds it is being supported the initial phase of its operationalization
- Activities have been prioritized with stakeholders and ToRs have been written and bidding process
  has started for: (a) Design of indicators for monitoring, reporting and evaluation of forest
  degradation, (b) Regulation for the National Forests Fund (FONABOSQUES from the PROBOSQUE
  Law), (c) Support for linking the preparation of the National REDD + Strategy with strategical
  political agendas of prioritez sectors in the country, (d) Pilot study case for innovation in the
  manufacture of clean cookstoves, (e) Digitalization of polygons incentivized during the term of
  Forestry Incentives Program (PINFOR), and (f) Design and development of image of the National
  REDD+ Strategy

#### **Sub-component 2c. Implementation framework:**

- It has been hired and is has stared the Systematization of the policies and forest governance Framework.
- Advisory Group was formed of stakeholders including: climate change, legal, and financial departments/units of GCI, representatives of civil society, Group of REDD+ Implementers, and others. The Advisory Group meets monthly to jointly draft a technical, legal, and financial proposal that will permit coordination of the various specific benefit distribution mechanisms of the REDD+ activities with the national scheme.

#### Sub-component 2d. Social and environmental impacts:

- It has been hired the consulting firm which will elaborate SESA, ESMF and FGRM
- Elaboration process for the National Safeguards Approach and the Roadmap for the inclusion of gender considerations in the three REDD+ phases (readiness, implementation and payment results).

#### Component 3 Reference emissions level

- Eleven GIS technicals were hired to support GIMBUT in the elaboration of the national reference emission scenarios
- In June 2016 this product will be finished
- Development of the Reference Emission Scenarios under the Carbon Fund Methodological Framework for each REDD+ modality in the 5 REDD+ regions, covering the whole country
- In bidding process of equipment to sthrenght the four GIS Units of GCI

The environmental and social standards were taken into account during the elaboration of the terms of reference of all the activities within the four components of the Strategy.

## Description of planned stakeholder engagement activities during the whole project duration (incl. timing and target groups):

In 2015 the preparation of products within the four components of the strategy were done through extend participatory process with stakeholders from: public sector, local communities, indigenous people, NGOs, private sector, academia, amongst others. The the main activities are: (i) Interpretation of Cancun Safeguards and elaboration of the National Safeguard Approach, (ii) Elaboration of a roadmap to include gender considerations into the national REDD+ process, (iii) Proposal for the national benefit sharing mechanism, (iv) Reference emission scenarios, amongst others.

# Description of progress in stakeholder consultation, participation and the Feedback & Grievance Redress Mechanism for Readiness (FGRM) on the country level related to this grant:

The elaboration of the four components of the REDD+ National Stragy is being done with multiple stakeholders within workshops and wok meetings. Exchange information with stakeholders is being done through the REDD+ subportal web under the Ministry of Environment webpage. It has been hired the consultin firm for the design of the Grievance Redress Mechanism for Readiness, which will be based on existing mechanisms under the GCI.

It has continued the articulation of the thematic groups that are developing different products of the Strategy, for example, for the development of reference emission scenarios, MRV system, benefits sharing mechanisms, among others.

## Description of progress of preparation of ESMF until 01/05/2015 (report date). Is the ESMF prepared in accordance with the Common Approach?:

With regard to the FCPF Common Approach to Environmental and Social Safeguards, the IADB worked with the FMT to prepare the terms of reference of the GRM, SESA, ESMA, and others, so as to guarantee

consistency in implementation under the terms set forth in the Common Approach. The specific areas involving potential gaps between IADB and World Bank policies are limited and specific and none has arisen in the actual operating context of FCPF activities in Guatemala handled by the IADB.

It has been hired a consulting firm for the development of SESA and ESMF, and it is expected to be done in 2017.
