Nicaragua Revised R-PP, dated March 17th, 2013

Completeness Check by FMT

Nicaragua submitted a Readiness Preparation Proposal (R-PP) to the Facility Management Team (FMT) in June 2012, which was reviewed by a Technical Advisory Panel (TAP) and a working group consisting of Participants Committee (PC) members established for this purpose.

The PC reviewed the R-PP in accordance with Section 11.1 (b) of the Charter Establishing the FCPF (Charter) at its twelfth meeting in March, 2012 in Santa Marta, Colombia; and acknowledged the extensive efforts made by Nicaragua, and the high quality of the R-PP. The PC decided, through **Resolution PC/12/2012/4** to allocate funding to Nicaragua to enable it to move ahead with the preparation for readiness. For this purpose, the resolution requested Nicaragua to submit a revised R-PP (Revised R-PP) to the FMT, reflecting the key issues in the summary report prepared by the FMT included in the annex of this resolution.

In the following, the FMT presents the results of the completeness check. This summary will be posted on the FCPF website and FMT will notify the PC of its availability.

The Revised Version follows the R-PP template version no 6. It was presented in Spanish language at the time of the completeness check.

The following were the key issues that Nicaragua needed to address in the Revised Version of the R-PP before entering into a Readiness Preparation Grant Agreement with the World Bank as Delivery Partner.

- 1. Replace the proposed work plan to develop a reference level, as outlined in Component 3 of the R-PP, with the proposal of such plan as presented at the Ninth Meeting of the PC in Oslo, Norway, in June 2011 (PC 9);**

The reason for this request was the fact that the TAP and PC considered that the previous version of the proposed work plan was more consistent than the later version.

Nicaragua replaced the work plan to develop a reference level with the previous version of June, 2011, as requested. The changes can be found on the pages 159 – 192 of the revised R-PP version.



Completeness confirmed. The FCPF FMT has verified that the revised R-PP complies with the requirement as formulated in the resolution.

2. Prepare the initial design of and a work plan for an integrated information system that addresses multiple socio-economic benefits as required under Component 4b of the R-PP.

In response to this request by the PC, Nicaragua carried out two regional and one national workshop that helped design the initial workplan for the integrated information system addressing multiple socio-economic benefits. All four major groups of Indigenous Peoples participated in these workshops (North Central Pacific, RAAN, RAAS and Alto Coco), in addition to the Alianza Nicaraguense ante el Cambio Climatico including more than 40 Civil Society Organizations; the government, representatives of the private sector and universities. The respective changes to the text of subcomponent 4.b. are found on pages 205 – 211.

Completeness confirmed. After careful comparison the FMT considers the request from the PC resolution as answered.
