Charter: Composition and Process

- Composition: 2 groups
 - 10 Members from REDD Country Participants
 - 10 Members collectively from Donor Participants and Carbon Fund Participants
- Each group elects its own representatives and determines the criteria for election
- Selection of PC members from Donor Participants and Carbon Fund Participants should take into account:
 - Amount of Participant's contribution
 - Equal representation of Donor Participants and Carbon Fund Participants in the PC

Charter: PC Members and Non-Members

- Term: one year until next Participants Assembly meeting
- PC members are representatives of their constituency and should regularly consult their constituency
- Participants that are not PC members can participate in PC meetings as observers, but not vote

Current PC Composition: REDD Countries

PC members from REDD Country Participants:

Gabon, DRC, Ghana, Madagascar, Bolivia, Guyana, Panama, Costa Rica*, Nepal and Vietnam

* Mexico replaced Costa Rica when it signed its Participation Agreement (in September 2009)

Criteria adopted by REDD Country Participants:

Geographical balance

Current PC Composition: Donor Participants & Carbon Fund Participants

PC members from Donor Participants and Carbon Fund Participants:

AFD, Australia, Germany, Japan, Netherlands, Norway, Switzerland, TNC, UK and US

- Bureau members: Australia, Switzerland and TNC
- Spain and Finland would be elected to the PC at the Participants Assembly in 2009 (PC1 Decision)
- Criteria for election: a draft has been circulated by the Bureau for consideration by Donor Participants & Carbon Fund Participants
