



REDD+ Readiness in DRC: Where We Come From



Disbursements: DRC is FCPF Champion



1st country that disbursed FCPF \$3.4m grant Disbursements as of today: \$5.14m (60% of \$8.6m)

Update on Grant Monitoring and Reporting (1)

Component 1a:

- Coordination secured through functional CN-REDD
- Support to 5 Provincial Focal Points, elaboration of provincial REDD+ strategies ongoing

Component 1b:

- International REDD+ University in Sept. 2014 with 320 participants including administration, CSO and IP, private sector
- Inter-ministerial high-level segment focused on integration of REDD+ sectoral policies (result: road map)
- Outreach activities in provinces
- Various information activities, e.g. radio communication for communities, translation of documents in local languages
- NGO OCEAN recruited to lead consultations in ER program, in particular with local communities and IP (\$95,000)

Update on Grant Monitoring and Reporting (2)

Component 2c:

- Work ongoing on benefit sharing mechanism: national guidelines, benefit sharing principles and plan for ER program
- Design for REDD+ registry conceptualized, now IT programming
- Feedback & Grievance Redress Mechanism (FGRM) work in progress **Component 2d:**
- Social & Environmental Strategic Assessment (SESA) concluded and report available, Environmental & Social Management Framework (ESMF) approved by WB safeguards team with 5 frameworks:
 - 1. Indigenous Peoples Planning Framework
 - 2. Resettlement Policy Framework
 - 3. Process Framework
 - 4. Cultural Heritage Framework
 - 5. Pesticide Framework

Component 3: MRV expert in CN-REDD team recruited, close collaboration with UN-REDD / FAO

Key Issues

- Significant progress on key outputs: National REDD+ strategy, reference level, MRV system, ESMF, FGRM
- Parallel advancements on national level readiness and development of jurisdictional ER program to benefit local communities and other stakeholders
- Investments very much needed to implement:
 - National reforms as part of Economic Governance Matrix, e.g. land tenure, land use planning
 - Investment Plan of National REDD+ Fund, endorsed by Ministers of Finance and Environment, which prioritizes investments to implement national REDD+ strategy including Mai Ndombe
