

Argentina	Submitted an R-PP in April for formal review at PC 6.					
Bolivia	A draft R-PP was sent on an informal basis.					
Cambodia	H as begun working on the R-PP.					
Cameroon	R-PP tentatively expected for March 2011.					
CAR	Will benefit from support provided under the Partnership AFD/International NGOs supporting R-PP preparation. The R-PP is expected for November 2010.					
Chile	Chile is not interested in engaging until funds are available. No PA signed.					
Colombia	The formulation grant is in process and may be signed by July 2010. The R-PP is tenatively expected for November 2010.					
Costa Rica	Made informal presentation of R-PP at PC4. Forumlation grant is signed and disbursing. R-PP will be reviewed at PC6.					
DR Congo	R-PP assessed by PC 5 and preparation grant authorized. The R-PP revision is expected soon. \$200k Formulation grant is already disbursing.					
El Salvador	W B is not involved in forestry in the country. Another delivery partner may need to be identified.					
Equatorial Guinea	No signed PA. Will benefit from support provided under the Partnership AFD/International NGOs supporting R-PP preparation.					
Ethiopia	R-PP formulation grant signed and disbursing. R-PP is expected in March 2011.					
Gabon	R-PP formulation grant signed. Not yet disbursing. R-PP is expected for March 2011.					
Ghana	R-PP assessed by PC 5 and grant authorized. \$200k formulation grant is disbursed. Readiness grant is expected in FY11.					
Guatemala	An R-PP is being formulated.


# Components of the FCPF Dash Board 3. Track Total Expenditures, Commitments & Grants
