# Nepal Draft R-PP: Initial comments by the TAP

## Overall Summary of the Review: 1

Middle Hills

#### Strengths of the RPP Document:

 R-PP is very well composed and addresses all the key issues requested by FCPF for each of the six components

- It provides in-depth information about the historical and current deforestation in Nepal for the country's three regions
  High Mountain, Middle-Hills and Terai and Siwalik.
  Deforestation in the Mid-Hills has been successfully managed through participation of local communities.
- In formulating the R-PP, Nepal conducted extensive consultation process that included 57 workshops with participation of >3000 persons.
- The proposal notes the need to deal with adaptation and mitigation simultaneously, which is very important and should serve as a good example for REDD policy considerations in other countries.
- The R-PP highlights the ongoing REDD-related activities supported by other bilateral and multilateral entities.
- It provides a comprehensive summary of how it plans to prepare a REDD strategy.
- The proposed budget provides a good breakdown and allocates about 40% of the funding each for governance and technical aspects.

## Overall Summary of the Review: 2

Selected areas that need further work in the R-PP or during the implementation: Challenges and Recommendations

- A new constitution is being planned and its proposed administrative, legal, and infrastructural implications could have a significant impact on a REDD strategy.
  - ➤ We recommend that R-PP should describe a process to respond to future changes in the constitution.
- Nepal has one set of comprehensive historical nation-wide data on deforestation from 1970s. Subsequent data are siteor region-specific.
  - ➤ Much, if not all, of the work that normally relies on historical data will be done by collecting new data during the REDD+ preparation phase.

### Overall Summary of the Review: 3

Selected areas that need further work in the R-PP or during the implementation: Challenges and Recommendations

- R-PP proposes to set up monitoring mechanisms and ways to collect national data. Information is needed on what will be monitored, who will monitor and how it will be done.
  - ➤ A study would help to examine how community based monitoring might apply to the Terai region
- Consideration of private forests that have grown significantly in Nepal needs better coverage.
  - ➤ The proposed monitoring program should take these forests into consideration.
