#### **World Bank**

- Focus on Poverty Reduction, including the Millennium Development Goals
- Commitment to Environmentally and Socially Sustainable Development, supporting Outcome of Rio and Johannesburg Summits
- Promoting Country Driven Development Effectiveness, including the Paris Declaration and Accra Agenda for Action
- Addressing Climate Change both Mitigation and Adaptation, as well as REDD+ – as a Development Issue
- Providing Global Knowledge to Support Public and Private Sector Policies, Strategies, Programs and Projects

### Safeguard Policies: Key Objectives

- Promote sustainable development and support integration of environmental and social aspects of programs and projects into decision making process
- Provide a mechanism for addressing environmental and social issues in program and project design, implementation and operation
- Use to identify and manage impacts and risks
- Provide a framework for consultation and disclosure
- Support development effectiveness increase results on the ground both short and long term

#### **Complementary Objectives**

- Increase effectiveness, efficiency and timeliness in the application of safeguard policies, including measures to facilitate improved harmonization within the World Bank Group
- Update the Policy Framework to address emerging issues and recent developments in methods and approaches for assessment of impacts and risks

- Fall 2013 2<sup>nd</sup> Stage of Consultations on Revised Draft Policy
- December 2013 Proposed Presentation to World Bank Board of Executive Directors

2012 and 2013 - Meetings Planned to be Held in Conjunction with United Nations Permanent Forum on Indigenous Issues in New York

# Indigenous Peoples Policy: Issues Raised

- The Indigenous Peoples Policy should remain a stand-alone policy
- The Bank should adopt a stand-alone Human Rights safeguard policy
- The Bank should adopt the standard of Free, Prior and Informed Consent for Indigenous Peoples
- The Bank should carry out more extensive consultations with Indigenous Peoples, especially during the safeguard policy updating and consolidation process
- A rights-based approach is particularly important for climate programs, including REDD+

#### Methodology

- Search in World Bank databases for projects triggering OP 4.10
- Development of a Fact Sheet for every project
- Built on previous Social Development Review experience
- Analysis of IPPs in 5 categories
  - 1. Screening
  - 2. Social Assessment
  - 3. Consultation, participation, community support
  - 4. Quality of the Indigenous Peoples Plans (IPPs)
  - 5. Special considerations

#### Methodology

- Ranking of IPPs according to 15 criteria
- Analysis of Indigenous Peoples Policy Frameworks (IPPFs) in 3 categories
  - 1. Identification of potential effects
  - 2. Plans for Social Assessment and consultation
  - 3. Provisions for screening, evaluation of effects, and preparation of IPPs
- Ranking of IPPFs according to 7 criteria

# **Key Findings**

- The quality of project IPPs is significantly improving, particularly regarding:
  - > Staff and Borrower awareness of the policy
  - Screening for the application of the policy
  - > Tailoring benefits to indigenous communities
  - > Avoidance of involuntary resettlement
  - Use of consultation processes designed for indigenous communities

# **Key Findings**

- Areas for strengthening:
  - ➤ Analysis of the legal framework
  - Social Assessment of indigenous communities
  - Documentation of broad community support
  - Adoption of specific monitoring indicators
  - Improved in-country disclosure
  - Increased focus on protection of land rights
  - > Establishment of grievance mechanisms

#### **Recommended Actions**

- Expanded knowledge sharing and training on OP 4.10
- Preparation of Indigenous Peoples Country Profiles in selected countries
- Increased promotion of country-based dialogue mechanisms involving Indigenous Peoples
- More emphasis on issues related to land and resources rights in Bank operations
- Inclusion of institutional strengthening and capacity building of Indigenous Peoples organizations in IPPs
- Preparation of regional operational guidelines on the application of OP 4.10
- Streamlining of Bank information databases
- Ensuring more effective in-country disclosure of OP 4.10 instruments (IPP or IPPF)
