Process of Endorsing ERPA General Conditions

| Process | Legal Document | Purpose |

| Endorsement of ERPA General Conditions (GCs) | Step 1: ERPA Term Sheet Step 2: | PC participants agree on certain cornerstones of the ERPA General Conditions (in the form of general terms and procedures) |
| | ERPA GCs (incl. template on ERPA Commercial Terms) | PC participants endorse ERPA GCs that are applicable to all FCPF ERPA (non-negotiable) together with a template of the ERPA Commercial Terms (negotiable) |

Process of Entering into FCPF ERPAs

| Process | Legal Document | Purpose |

| Entering into FCPF ERPAs | Step 1: Letter of Intent (LOI) | Legally-binding agreement between Trustee and REDD Country Participant / authorized entity which includes provisions that shall guide the ERPA negotiation process (e.g. a period to negotiate an ERPA in good faith on basis of exclusivity) and is based on an LOI template that has been previously agreed upon with Carbon Fund Participants |
| | Step 2: FCPF ERPA (incl. endorsed ERPA GCs & Commercial Terms) | Legally-binding agreement between Trustee and REDD Country Participant / authorized entity on the sale & purchase of ERs generated by a specific ER Program |
