MANAGEMENT'S ASSERTION REGARDING EFFECTIVENESS OF INTERNAL CONTROLS OVER FINANCIAL REPORTING OF THE MODIFIED CASH BASIS TRUST FUNDS

The International Bank for Reconstruction and Development ("IBRD"), the International Development Association ("IDA"), the International Finance Corporation ("IFC"), and the Multilateral Investment Guarantee Agency ("MIGA") (collectively referred to herein as "the Bank"), as administrators for the modified cash basis trust funds, are responsible for establishing and maintaining effective internal control and procedures over financial reporting for trust fund activities which are designed to provide reasonable assurance to the Bank's Management and Board of Directors regarding the preparation of reliable trust fund financial reports prepared on the cash receipts and disbursements basis of accounting modified to record the share in pooled cash and investments at fair value ("modified cash basis of accounting").


Assertions as of June 30, 2009 made by Management in this document pertain to the specific control objectives relevant to the effectiveness of internal control over financial reporting of trust fund activities using the modified cash basis of accounting (the "modified cash basis trust funds"). The specific management assertions are set forth below:

1. Contributions from Donors are recorded in the appropriate trust fund on a timely basis.
2. Assets underlying funds held in trust are segregated from funds of the Bank and are in the form of cash and investments managed by the Bank.
3. Transactions recorded in the underlying financial records and the financial reporting of each trust fund are valid and complete.
4. Investment income is earned and credited to the appropriate trust fund in accordance with the terms and provisions of the trust fund agreements.
5. Disbursements follow relevant Bank policies and procedures.
6. Fees for administering each trust fund are charged in accordance with the terms and provisions of the trust fund agreements.
7. Financial reporting is in compliance with the requirements set forth in the legal agreements entered into with the donors.

MANAGEMENT'S ASSERTION REGARDING EFFECTIVENESS OF INTERNAL CONTROLS OVER FINANCIAL REPORTING OF THE MODIFIED CASH BASIS TRUST FUNDS (Cont'd)

The Bank's internal control and procedures over financial reporting of the modified cash basis trust funds contain self-monitoring mechanisms, and actions are taken to correct deficiencies as and when identified. Even an effective internal control system, no matter how well designed, has inherent limitations, including the possibility of human error and the circumvention or overriding of controls, and therefore can provide only reasonable assurance with respect to financial report preparation. Such human error, circumvention, or overriding of controls may, among other things, result in ineligible expenditures charged to a trust fund which systems of internal control cannot always detect at the time of recording. Management does not perceive this to be indicative of an overall ineffective system of internal control given that procedures for the ex-post compliance review are in place.


The Bank assessed its internal control over financial reporting of the modified cash basis trust funds as a whole as of June 30, 2009. This assessment was based on the criteria for effective internal control over financial reporting described in the "Internal Control - Integrated Framework" issued by the Committee of Sponsoring Organizations of the Treadway Commission. Based on this assessment, the Bank has maintained effective internal control over financial reporting for the modified cash basis trust funds, as of June 30, 2009.





We have examined management's assertion, included in the accompanying "Management's Assertion Regarding Effectiveness of Internal Control over Financial Reporting of the Modified Cash Basis Trust Funds", that the International Bank for Reconstruction and Development, the International Development Association, the International Finance Corporation, and the Multilateral Investment Guarantee Agency (together referred to as the Administrators) maintained effective internal control over financial reporting for the Modified Cash Basis Trust Funds as listed in note 13, as of June 30, 2009 (Modified Cash Basis Trust Funds), based on the criteria established in *Internal Control – Integrated Framework* issued by the Committee of Sponsoring Organizations of the Treadway Commission (COSO). Management of the Administrators is responsible for maintaining effective internal control over financial reporting, and for its assertion on the effectiveness of internal control over financial reporting, included in the accompanying "Management's Assertion Regarding Effectiveness of Internal Control over Financial Reporting of the Modified Cash Basis Trust Funds." Our responsibility is to express an opinion on management's assertion based on our examination.

We conducted our examination in accordance with attestation standards established by the American Institute of Certified Public Accountants and the International Standards on Assurance Engagements as issued by the International Auditing and Assurance Standards Board. Those standards require that we plan and perform the examination to obtain reasonable assurance about whether effective internal control over financial reporting was maintained in all material respects. Our examination included obtaining an understanding of internal control over financial reporting, assessing the risk that a material weakness exists, and testing and evaluating the design and operating effectiveness of internal control based on the assessed risk. Our examination also included performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion.

An entity's internal control over financial reporting is a process effected by those charged with governance, management, and other personnel, designed to provide reasonable assurance regarding the preparation of reliable financial statements in accordance with an applicable financial reporting framework, which in the case of the Modified Cash Basis Trust Funds' combined statement of receipts, disbursements and fund balance prepared by the Administrators is the modified cash basis of accounting as described in note 2, a comprehensive basis of accounting other than generally accepted accounting principles. An entity's internal control over financial reporting includes those policies and procedures that (1) pertain to the maintenance of records that, in reasonable detail, accurately and fairly reflect the transactions and dispositions of the assets of the entity; (2) provide reasonable assurance that transactions are recorded as necessary to permit preparation of financial statements in accordance with the applicable financial reporting framework of the modified cash basis of accounting described in note 2, and that receipts and expenditures of the entity are being made only in accordance with authorizations of management and those charged with governance; and (3) provide reasonable assurance regarding prevention, or timely detection and correction of unauthorized acquisition, use, or disposition of the entity's assets that could have a material effect on the Modified Cash Basis Trust Funds Combined Statement of Receipts, Disbursements and Fund Balance.

We have audited the accompanying combined statement of receipts, disbursements and fund balance of the Modified Cash Basis Trust Funds listed in note 13 for the year ended June 30, 2009 (Modified Cash Basis Trust Funds). This financial statement is the responsibility of the management of the Administrators, consisting of International Bank for Reconstruction and Development, International Development Association, International Finance Corporation, and Multilateral Investment Guarantee Agency. Our responsibility is to express an opinion on this financial statement based on our audit.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America and International Standards on Auditing. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the combined statement of receipts, disbursements and fund balance is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the combined statement of receipts, disbursements and fund balance. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of the combined statement of receipts, disbursements and fund balance. We believe that our audit provides a reasonable basis for our opinion.

As described in note 2, the financial statement was prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles.

In our opinion, the financial statement referred to above presents fairly, in all material respects, the cash receipts, disbursements, and fund balance of the Modified Cash Basis Trust Funds for the year ended June 30, 2009, on the basis of accounting described in note 2.

The accompanying combined statement of receipts, disbursements and fund balance of the Modified Cash Basis Trust Funds for the year ended June 30, 2008 were not audited by us and, accordingly, we do not express an opinion on it.

We also have examined, in accordance with the attestation standards established by the American Institute of Certified Public Accountants and the International Standards on Assurance Engagements issued by the International Auditing and Assurance Standards Board, the assertion prepared by management of the Administrators that the Administrators maintained effective internal control over financial reporting of the Modified Cash Basis Trust Funds as of June 30, 2009, in accordance with the criteria established in *Internal Control – Integrated Framework* issued by the Committee of Sponsoring Organizations of the Treadway Commission (COSO), and our report dated September 14, 2009, expressed an unqualified opinion on management's assertion.

NOTES TO THE COMBINED STATEMENT OF RECEIPTS, DISBURSEMENTS AND FUND BALANCE

June 30, 2009

Note 1 - Organization and operations

The International Bank for Reconstruction and Development (IBRD), the International Development Association (IDA), the International Finance Corporation (IFC), and the Multilateral Investment Guarantee Agency (MIGA), in this financial statement collectively referred to as “the Bank” enter into administrative arrangements, individually or jointly, with various external donors for funding the trust funds. The Bank is the Administrators of the trust funds.

Trust funds provide grant funds to meet diverse development needs, including project preparation, technical assistance, advisory services, debt relief, post conflict transition, and co-financing of lending projects.

Basis of combination

Individual trust funds which are accounted for and reported using the modified cash basis of accounting, as described in note 2, are included in the combined statement of receipts, disbursement and fund balance (Combined Financial Statement). Transactions between trust funds included in this statement are eliminated. The list of trust funds that are combined in this financial statement is provided in note 13. These trust funds are referred to throughout the notes as “modified cash basis trust funds”.

IBRD performs certain administrative, accounting, financial reporting and treasury services related to trust fund activities on behalf of the Bank. IBRD, IDA, IFC, and MIGA are members of the World Bank Group, which also includes the International Centre for Settlement of Investment Disputes. Amounts paid into the modified cash basis trust funds but not yet disbursed, are managed by IBRD which maintains an investment portfolio (the Pool) for all of the trust funds administered by the entities of the World Bank Group. IBRD maintains all trust fund assets separate and apart from the funds of the World Bank Group.

NOTES TO THE COMBINED FINANCIAL STATEMENT

Note 1 - Organization and operations (continued)

Trust funds activities are carried out in the following ways:

Recipient-executed activities

Recipient-executed trust funds involve activities carried out by a recipient third-party executing agency. The Bank enters into grant agreements with and disburses funds to such recipients, who are responsible for complying with the terms and conditions stipulated in the grant agreements, including submission of progress and financial reports for these activities to the Bank.

Bank-executed activities

Bank-executed trust funds involve the execution by the Bank of activities as described in the relevant administration arrangement with donors. The Bank prepares the terms of reference, procures goods and services, disburses funds, and submits progress and financial reports for these activities to donors.

Financial intermediary funds

Financial intermediary funds comprise a heterogeneous mix of trust funds not covered by either Bank-executed or Recipient-executed trust funds. They include funds with complex financial schemes, or arrangements in which the Bank provides specific administrative or financial services with a limited fiduciary or operational role. Arrangements include the administration of a variety of debt service trust funds, fiscal agency services funds and other more-specialized limited fund management roles. Financial intermediary funds are held and disbursed in accordance with instructions from donors.

Note 2 - Significant accounting policies

Basis of presentation

The accompanying combined financial statement has been prepared on the cash receipts and disbursements basis of accounting, modified to record the share in pooled cash and investments at fair value ("modified cash basis of accounting"). Accordingly, net investment income includes realized and unrealized investment income (loss).

Note 2 - Significant accounting policies (continued)

The modified cash basis of accounting is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP) or International Financial Reporting Standards (together the generally accepted accounting principles). With the exception of investment income, receipts are recorded when collected (i.e., when credited to the trust fund) rather than when pledged/earned, and disbursements are recorded when paid (i.e., when debited from the trust fund). This financial statement is not intended to be a presentation in conformity with generally accepted accounting principles; however certain information pertaining to the fair value of financial instruments is presented in accordance with the pertinent U.S. GAAP pronouncements as described below.

In accordance with policies adopted for the administration of the modified cash basis trust funds, certain transactions, including donor contributions not credited to a trust fund at the financial statement date due to timing or other reasons, reposting of disbursements in the ordinary course of business as deemed necessary, and any refunds of previous disbursements deemed by management not to be eligible in accordance with the trust fund agreements, are reported in the combined statement of receipts, disbursements and fund balance in the period in which the transaction is credited/debited to the trust fund.

The combined statement of receipts, disbursements and fund balance is expressed in U.S. dollars, the reporting currency. Fund balance consisting of share in pooled cash and investments denominated in currencies other than the U.S. dollar are translated at market exchange rates in effect at the financial statement date.

For reporting purposes, contributions received in currencies other than the U.S. dollar are translated at market exchange rates in effect on the date the receipt was reflected in the trust fund. Similarly, disbursements made in non-U.S. dollar currencies are translated at the market exchange rates in effect on the transaction dates.

Translation adjustments, as well as any transaction gains or losses are reported in the combined statement of receipts, disbursements and fund balance. However, transaction gains or losses arising from disbursements are borne by IBRD.

Note 2 - Significant accounting policies (continued)

In addition to the modified cash basis trust funds, the Bank administers a number of trust funds which are accounted for and reported under either generally accepted accounting principles or the special purpose basis of reporting. Trust funds administered by the Bank that are not accounted for and reported under the modified cash basis of accounting are excluded from the combined statement of receipts, disbursements and fund balance. Transfers between trust funds included in the combined statement of cash receipts, disbursements and fund balance are eliminated from the financial statement; however, transfers to/from trust funds that are not included in the combined statement of receipts, disbursement and fund balance are reported as transfers in the financial statement.

The preparation of the financial statement in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of fund balances and related disclosure at the date of the financial statement and the reported amounts of receipts and disbursements during the reporting period. Actual results could differ from these estimates.

Share in pooled cash and investments and investment income, net

As described in note 1, the Pool is divided into sub-portfolios to which allocations are made based on fund specific investment horizons, risk tolerances and/or other eligibility requirements for trust funds with common characteristics as determined by IBRD. Generally, the Pool is invested in liquid financial instruments such as money market instruments, government and agency obligations, mortgage-backed securities and other high-grade bonds. The Pool may also include securities pledged as collateral under repurchase agreements with other counterparties and receivables from resale agreements for which it has accepted collateral. Additionally, the Pool also includes derivative contracts such as currency forward contracts, plain vanilla swaps and callable swaps linked to interest rates, foreign exchange rates and equity indices.

The Pool is a trading portfolio and is reported at fair value with all gains/losses recognized in net investment income. Share in pooled cash and investments represents the modified cash basis trust funds' allocated share of the Pool's fair value at the end of the reporting period.

NOTES TO THE COMBINED FINANCIAL STATEMENT

Note 2 - Significant accounting policies (continued)

Net investment income consists of the modified cash basis trust funds' allocated share of: interest income earned by the Pool, realized gains/losses from the sales of securities, and unrealized gains / losses resulting from recording the assets held by the Pool at fair value.

Financial Accounting Standards Board's (FASB's) Statement of Financial Accounting Standards No. 157, *Fair Value Measurements* (FAS 157) became effective for financial statements issued for fiscal years beginning after November 15, 2007. FAS 157 defines fair value, establishes a consistent framework for measuring fair value, establishes a fair value hierarchy based on the quality of inputs used to measure fair value and expands disclosure requirements about fair value measurements. FAS 157 also requires that the valuation techniques used to measure fair value maximize the use of observable inputs and minimize the use of unobservable inputs. Note 11 provides further details on the fair value measurement of the Pool pursuant to FAS 157, which has been applied for the Pool from July 1, 2008.

Note 3 - Contributions

Contributions represent funds provided by donors, including the Bank, in support of various trust fund activities. Donors provide cash contributions either directly or against unconditional promissory notes made payable to the Administrator upon demand. Contributions are recognized in the modified cash basis trust funds upon the latter of the receipt of funds, or the receipt of the signed and countersigned administration agreements.

Note 4 - Other receipts

Other receipts consist primarily of receipts for advisory services, service fee and repayments of loans disbursed by Trust Fund for Gaza and West Bank, project costs reimbursed by the donors, refunds from projects, and reimbursements of administrative fees and expenses not deemed to be eligible disbursements.

NOTES TO THE COMBINED FINANCIAL STATEMENT

Note 5 - Project-related disbursements

Project-related disbursements represent amounts incurred for trust fund activities consistent with the terms of the agreement. These include:

- a. Disbursements from Bank-executed trust funds to support: (i) the Bank's own work program, including analytical and advisory activities, (ii) project-related activities, and (iii) trust fund administration activities including amounts for direct staff cost, related benefits and overhead costs.
- b. Disbursements from Recipient-executed trust funds to third-party recipients for carrying out development activities and financing the investment and recurrent needs of service delivery, capacity building and technical assistance. These disbursements also include payments to IBRD from debt service trust funds.
- c. Disbursements from Financial intermediary funds in accordance with instructions from donors.

As part of its regular control framework, IBRD performs various compliance reviews of trust fund activities, which may result in the identification of certain matters which could result in ineligible expenditures related to the modified cash basis trust funds. In the event that disbursements are identified which are deemed not be eligible in accordance with the relevant agreements for the modified cash basis trust funds, management will consult with the donors to determine the appropriate remedy.

Note 6 - Administration arrangements

In carrying out the activities of Bank executed trust funds, the Bank makes payments initially from its own resources to external parties. These payments are periodically reimbursed to the Bank from the modified cash basis trust funds. Disbursements from modified cash basis trust funds represent the repayment to the Bank for direct staff costs, related benefits and overheads incurred for activities consistent with the purposes of the modified cash basis trust funds in accordance with the administrative agreements.

NOTES TO THE COMBINED FINANCIAL STATEMENT

Note 7 - Administration fees

To assist in the defrayment of the costs incurred for the administration, supervision and oversight of modified cash basis trust funds, the Bank deducts fees pursuant to the legal agreements with donors. In exceptional arrangements, the Bank is not compensated for the services provided to administer the funds.

Note 8 - Refunds to donors

Refunds to donors primarily represent the return of undisbursed fund balances upon completion of individual trust fund activities. Refunds to donors also include remittances to IDA, representing the repayment of funds previously disbursed to recipients of the Trust Fund for Gaza and West Bank as credits. These repayments were first credited to the Trust Fund for Gaza and West Bank and then remitted to IDA.

Note 9 - Advances received from and repaid to the Bank

Advances received from the Bank represent amounts temporarily granted by the Bank to the modified cash basis trust funds in anticipation of receipt of contributions committed by donors. Advances repaid to the Bank represent repayment of such advances by the modified cash basis trust funds to the Bank.

Note 10 - Transfers from/to other trust funds

Transfers from/to other trust funds represents transfer of funds between the trust funds included in the combined statement of receipts, disbursements and fund balance and trust funds excluded from the combined statement of receipts, disbursements and fund balance.

Note 11 - Fair value of financial instruments

Effective July 1, 2008, FAS 157 was applied to the cash and investments held in the Pool. As discussed in note 2, the cash and investments of all trust funds administered by the Bank are managed in a pooled investment portfolio, as such all investment decisions are made and consequences monitored at the Pool level. The ensuing disclosure on fair value measurement and fair value hierarchy is therefore at the Pool level pursuant to FAS 157, followed by the fair value amount of the trust funds' share in the pooled cash and investments at the end of the reporting period.

Fair value measurements (FAS 157)

IBRD has an established and documented process for determining fair values of the Pool. Fair value is based upon quoted market prices, where available. Financial instruments for which quoted market prices are not readily available are valued based on discounted cash flow models. These models primarily use market-based or independently-sourced market parameters such as yield curves, interest rates, volatilities, foreign exchange rates and credit curves.

Summarized below are the techniques applied in determining the fair values of financial instruments.

Investment securities

Where available, quoted market prices are used to determine the fair value of trading securities. Examples include some government securities, mutual funds, futures and money market securities. For instruments for which market quotations are not available, fair values are determined using model-based valuation techniques, whether internally-generated or vendor-supplied, that include the standard discounted cash flow method using market observable inputs such as yield curves, credit spreads and prepayment speeds. Unless quoted prices are available, money market instruments are reported at face value, which approximates fair value.

Securities purchased under resale agreements and securities sold under agreements to repurchase

Securities purchased under resale agreements and securities sold under agreements to repurchase are reported at face value, which approximates fair value.

Derivative contracts

Derivative contracts include currency forward contracts, plain vanilla swaps and callable swaps linked to interest rates, foreign exchange rates or equity indices. Derivatives are valued using the standard discounted cash flow methods using market observable inputs such as yield curves, foreign exchange rates, or basis spreads.

Note 11 - Fair value of financial instruments (continued)

Fair value hierarchy

FAS 157 establishes a three-level fair value hierarchy under which financial instruments are categorized based on the priority of the inputs to the valuation technique. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1), the next highest priority to observable market-based inputs or inputs that are corroborated by market data (Level 2) and the lowest priority to unobservable inputs that are not corroborated by market data (Level 3). When the inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurement of the instrument in its entirety. Thus, a Level 3 fair value measurement of the instrument may include inputs that are observable (Level 2) and unobservable (Level 3). Additionally, FAS 157 requires that the valuation techniques used to measure fair value maximize the use of observable inputs and minimize the use of unobservable inputs.

Financial instruments representing the Pool's investments recorded at fair value are categorized based on the inputs to the valuation techniques as follows:

- Level 1: Financial instruments whose values are based on unadjusted quoted prices for identical instruments in active markets.
- Level 2: Financial instruments whose values are based on quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; or pricing models for which all significant inputs are observable, either directly or indirectly for substantially the full term of the instrument.
- Level 3: Financial instruments whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

As noted above, financial instruments in the Pool categorized as Level 3 represents less than 1% of the total Pool fair value at June 30, 2009 and is deemed immaterial. As such, no additional disclosure relating to (i) the changes in the fair value of the Pool's Level 3 financial instruments from July 1, 2008 to June 30, 2009, and (ii) the portion of gains or losses included in the Excess of receipts over disbursements line item for the period from July 1, 2008 to June 30, 2009 attributable to the unrealized gains and losses on the Pool's Level 3 financial instruments still held at June 30, 2009, and where the amounts are included in the statement of receipts, disbursements and fund balance has been presented.

As of June 30, 2009, the Pool does not have any financial instruments measured at fair value on a non-recurring basis.

Trust funds' share of the cash and investments in the Pool

The modified cash basis trust funds' share of the cash and investments in the Pool, which was allocated based on the specific investment horizons, risk tolerances and other eligibility requirements pursuant to the Agreements, has a fair value of \$8,215 million as of June 30, 2009. Net investment income in the amount of \$306 million was credited to the modified cash basis trust funds during the period from July 1, 2008 to June 30, 2009 based on their allocated share of the cash and investments in the Pool.

Note 12 - Guarantees

There are three investment guarantee trust funds, which are administered by MIGA, combined in this statement of receipts, disbursements and fund balance. MIGA, on behalf of these trust funds, issues guarantees against loss caused by non-commercial risks to eligible investors on qualified investments in the countries specified in the trust fund agreements. These guarantees expire between June 2012 and March 2015. At June 30, 2009, the guarantees amount to \$2.7 million (\$3.5 million – June 30, 2008).
