# Multiple Delivery Partners

- The PC requests the FMT to inform PC9 of other REDD Country Participants and potential delivery partners that might be appropriate for consideration, with a view to informing the decision at PC10 on Multiple Delivery Partners.

# FCPF Evaluation (1)

- The PC agreed to the following steps to finalize the first FCPF Evaluation Report:
  - Additional comments on the interim results presented at PC8 should be provided to Baastel and Nordeco by April 8, 2011 (Email: Carolina Vergara [carolina.vergara@baastel.com](mailto:carolina.vergara@baastel.com))
  - The draft evaluation report from the consultants will be available late April/early May. The FMT should inform the PC when the draft report is posted on the FCPF website. Comments should be sent by email to Baastel and Nordeco by May 21, 2011
  - The final report will be made available two weeks before PC9

## FCPF Evaluation (2)

- The PC invited participants to take part in a working group to structure the discussions on the recommendations from the Evaluation Report at PC9
- The working group can begin deliberations in May in preparation for PC9. The discussions of the working group may be facilitated by Baastel and Nordeco
- The FMT will propose to the PC by April 15, 2011 the budget required to cover the costs of: (a) facilitation of the working group; and (b) translation of the Evaluation Report. The proposed budget will be circulated to the PC by email for adoption on a no-objection basis.

# Enhancing the R-PP Process

- The PC requests:
  - PC members and observers to provide comments on the revised draft template by April 20, 2011
  - The FMT to consider any comments received, continue cooperation with the UN-REDD Programme, and provide a revised draft template as soon as is feasible
  - REDD Countries to use the December 22, 2010 template for submissions of R-PPs to be considered at PC9. Those REDD Countries that will be resubmitting their R-PPs at PC9 will be excepted, and may submit using the template they have already begun to use

# R-PP Submissions

- The PC requests REDD Country Participants to submit an R-PP by:
  - April 11, 2011, for new submissions for consideration at PC9 (April 25, 2011 for resubmissions)
  - August 1, 2011, for formal or informal consideration at PC10 (August 22, 2011 for resubmissions)

# Selection of Indigenous Peoples Observers

- The PC notes the Forest-Dependent Indigenous Peoples and Forest Dwellers' proposal to select their representative(s) to serve as the FCPF Observer(s) following the self-selection process that will be used for the Forest Investment Program (FIP).
- The PC requests the FMT to inform the PC of the budget implications of this proposal and prepare a draft amendment to the Charter for consideration by the PC.

The next FCPF meetings will be the following:

- PC9: Norway offered to host in Oslo (June 20-22, 2011)
- PA4/PC10: Germany offered to host in Berlin (October 17-19, 2011)

Colombia and Paraguay have each offered to host PC11. The FMT will liaise with the Bureau of the PC on this question.
