History

- Resolution CFM/6/2013/1 adopted at CF6 meeting in March 2013 in Washington DC
 - Selecting Costa Rica's ER-PIN in CF pipeline
 - Authorizing CF Trustee to negotiate a Letter of Intent (LoI) with Costa Rica for
 - Maximum Contract Value of USD 63 million
 - Maximum Contract Volume of 12 million ERs
 - Endorsing a LoI template
- Negotiations of LoI with FONAFIFO, Costa Rica (May-June 2013) and agreement on final execution version
- Approval of LoI by CF Participants either at CF7 or after
 2-week no objection period

Edits (as compared with Lol template)

 Recovery of up to USD 650,000 in Program Preparation Costs (PPC) Costs in the event of a violation of the exclusivity clauses in the LOI (Clause 2.1)

Issue

Exclusivity

(Clause 3.1-3.4)

Period

Clarification: PPC recovery clause does not apply where ERPA negotiations fail (although conducted in good faith), due to disagreement on any commercial ERPA terms (e.g. ER price, cost recovery, advance financing) Exclusivity Period of 20 months (from date of LoI)

➤ Includes minimum ERPA Negotiation Period of 10 months (from

- date the CF decides to proceed with ERPA negotiations (ERPA Negotiation Start Date)) > If ERPA Negotiation Start Date is later than 10 months from the date of the LoI, Exclusivity Period (automatically) extends to allow for a minimum ERPA Negotiation Period of 10 months
- (Clause 3.3) 'Good faith' defined as conducting ERPA negotiations 'in a fair and reasonable manner with a sincere intention to reach a final agreement on ERPA terms by end of the Negotiation Period' (Clause 3.4)

Issue	Edits (as compared with LoI template)
Disclosure of Information (Clause 5)	 Lol is a public document (non-confidential) In the event that either Party to the Lol requests during ERPA negotiations that the ERPA shall be a confidential document, such requesting Party shall disclose its rationale for such request
Termination (Clause 7)	 Insertion of an additional termination event, namely if the ERPA Negotiation Period has not started within 12 months from the date of the Lol
Dispute Resolution (Clause 8.2-8.3)	 Location of UNCITRAL conciliation/arbitration proceedings in Miami, USA Language of UNCITRAL conciliation/arbitration proceedings in English with simultaneous translation into Spanish
