Significant delays in the previous reporting period have begun to be addressed, however improvements are still needed in order to ensure successful implementation of grant activities.

Comment:

The Grant activities were officially launched on June 11, 2014 during a national workshop with the participation of all main stakeholders. During the first two years the Grant activities were slow and were dominated by the Technical Secretariat staffing. With the hiring of the Program Coordinator the process has accelerated for key contracts and activities but achievements were initially limited. In recent months the Technical Secretariat has made significant progress in producing reports, conducting stakeholder engagement, and engaging consultants for analytical products that are key for the REDD+ program.

1. Describe progress in how the Grant activities are being coordinated with other REDD+-related initiatives, including those funded by others.

Coordination with the other partners is currently ensured through: i) participation to the REDD+ partner's technical working group meeting on the monthly basis, (ii) meeting with them during implementation support missions and (iii) coordination through Technical Secretariat at the Ministry of Environment.

2. Describe any important changes in the technical design or approach related to the Grant activities.

A consolidated timeline processes has been agreed upon to accelerate REDD+ readiness activities.

3. Describe progress in addressing key capacity issues (implementation, technical, financial management, procurement) related to this Grant.

The hiring of fiduciary team has assisted in addressing the FM constraints. All technical staff are now hired, and the team has produced preliminary studies necessary to inform consultancies, all of which are now also underway, including: drivers of deforestation; national reference level; national forest monitoring system; benefit-sharing mechanism, financial arrangements, institutional arrangements, legal analysis, etc.

4. Describe progress in addressing social and environmental issues (including safeguards) related to the Grant. Is the SESA conducted in accordance with the Common Approach?

The firm to conduct the SESA has been hired, but the SESA process has been placed on hold pending results from the drivers of deforestation analysis and the identification of strategic options.

5. Is the ESMF prepared in accordance with the Common Approach?

The ESMF preparation is not started but will be prepared as part of the SESA process.

6. Describe progress in stakeholder consultation, participation and disclosure related to this Grant.

The stakeholders consultation continues to be led by the Ministry of Environment, Civil Society organization Platforms. ST-REDD consults regularly with the platform, as well as with additional civil society networks and platforms who have chosen not to be part of the official platform. In addition, ST-REDD has initiated a strategy for engaging private sector through collaboration with the IFC, with promising early signals from private sector actors. ST-REDD distributes a quarterly newsletter, and has conducted outreach to journalists and other government ministries and departments, as well as conducting monthly donor collaboration meetings.
