# Overall progress from 07/01/2014 to 06/30/2015 with regard to Implementation of Grant Financed Activities: Comment:

Since Grant effectiveness significant progress has been made in the implementation of Readiness Activities. Substantial effort has been put in developing Terms of Reference and processing contracts and as a result, the majority of Grant resources have already been committed in Project activities. Outputs and disbursements are expected to increase substantially in 2016.

# Grant follow-up and structure

#### Description and context of Grant:

The Readiness Preparation Proposal (R-PP) prepared by the Government of Chile identifies a broad set of activities to support the country in strengthening its technical and institutional capacities to participate in a future REDD+ mechanism. This set of activities is supported by different sources, which include multilateral and bilateral financing arrangements in addition to the Chilean government#s own contribution. The FCPF Participants Committee (PC) authorized grant funding of \$3.8 million in March 2013 (PC14) based on Chile#s submission of its R-PP in October 2012. The FCPF grant finances specific activities included in components 1, 2, 3 and 4 of the R-PP, specified in the Grant Assessment Note. These activities have been selected after technical discussions with the National Forestry Corporation (CONAF), taking into account the technical and financial needs of Chile#s REDD+ Readiness process, the comparative advantage of the World Bank in supporting them, as well as the complementarity with support made available by other partners as well as the ongoing GEF financed Sustainable Land Management Project (P085621).

#### Comment on follow up:

Follow up will be through the Emissions Reductions Program. Chile's request to participate in the Emissions Reductions Program has been endorsed. A Bank Executed Trust Fund to support preparation of Chile's Emissions Reduction Program Document (ERPD) has been approved and that Grant is also under implementation. Chile has started the process of ER Program Document (ER-PD) preparation and plans to present the ER-PD to the Carbon Fund in March 2016.

# Comment on component implementation progress

Component 1: Readiness Organization and Consultation (FCPF amount: US\$ 1,087,797)

Progress under this Component so far includes the bidding of a large contract to develop a university-based course aimed at strengthening CONAF#s staff capacity in the regional offices across the country on issues related to forests and climate change related to the national REDD+ Strategy. During the mission of July 2015, CONAF informed the Bank that the Forests and Climate Change Roundtable (planned to be supported under this subcomponent) would be substituted by the recently established Forest Policy Council, which includes the same groups of key stakeholders. As such, the majority of the funds related to participation, consultation and information sharing have been reassigned to Component 2 to support the Participation and Consultation Plan as part of the SESA and ESMF development process, which was under budgeted, ensuring synergies and the efficient use of resources. Progress on the FGRM is expected with the remaining use of the funds under this component.

Major progress has been achieved under this component, including: i) the contracting of a consortium led by a local university to lead a study on the drivers of deforestation and forest degradation, and barriers to the enhancement of forest carbon stocks at the regional and national levels, and the identification of strategic mitigation options; ii) the contracting of a second consortium of national and international experts to lead a legal and social analysis of land tenure, carbon rights, and benefit sharing options related to the national REDD+ strategy and the ER-Program; iii) the contracting of a third consortium of national legal experts to provide technical assistance and inputs for integrating concepts of Payments for Environmental Services in new forest legislation being drafted; iv) the bidding of a large contract to pilot new models of sustainable firewood collection and marketing through increased technical assistance; v) the development of a Participation and Consultation Plan, and the contracting of two consultants and a group of moderators to carry out a series of information dissemination and early dialogue workshops with key stakeholder groups in each region of the country, which will provide key inputs to the Strategic Environmental and Social Assessment of the REDD+ Strategy. Six workshops have been carried out so far. The same consultants are expected to develop the Environmental and Social Management Framework.

Component 3: Development of a National Forest Reference Emission Level and Monitoring Systems for REDD+ (FCPF amount: US\$ 300,000)

Major progress has been achieved under this component as well, which is implemented in synergy with the resources from the Carbon Fund of the FCPF in preparation of the ERPD. A consortium led by Winrock International, and including the National Forestry Institute and a major national University located in the temperate zone of the country has been tasked with providing technical assistance for the development of the National Forest Reference Level and MRV system with a focus on forest degradation. A submission to the UNFCCC is expected in early 2016. In addition, Terms of Reference have been developed for a contract to strengthen the timber traceability system with a focus on firewood.

Chile has developed a sound SESA and consultation plan that is currently under implementation.
