



## R-PP Completeness Check for Uruguay

### Background:

Uruguay submitted a Readiness Preparation Proposal (R-PP) to the Facility Management Team (FMT) in July 2013, in accordance with Resolution PC/14/2013/2, and the R-PP was reviewed by a Technical Advisory Panel (TAP), and a working group consisting of PC members established for this purpose;

At the sixteenth PC Meeting, Uruguay presented its R-PP and was encouraged to resubmit its R-PP for formal assessment and consideration for selection at the seventeenth PC Meeting;

Uruguay subsequently revised its R-PP, taking into account the issues that were identified in the R-PP assessments by the TAP and the PC working group, as well as those raised by the PC, as summarized in the Co-Chairs' Summary for the sixteenth PC Meeting. The revised R-PP was reviewed by the TAP and a working group consisting of the PC members established for this purpose, and was presented at the seventeenth PC Meeting on July 2-4, 2014 in Lima, Peru.

At this meeting, the PC adopted PC resolution PC/17/2014/8 deciding to allocate funding to enable Uruguay to move ahead with REDD+ readiness preparation.

Uruguay submitted a final revised R-PP to the FCPF FMT on April 1<sup>st</sup>, 2015. Completeness check by the FMT is formally required in the above-mentioned PC resolution.

The table below presents the results of the completeness check per issue raised in the Resolution.

A new section 2b5 was added with the title: "Prioritization of the activities to be undertaken under the REDD+ national strategy". This new section highlights the first step which is to establish the forest registry that will provide better information to understand the patterns of deforestation and degradation. It describes in detail the steps to gather the information and quantify the impact of deforestation and degradation, which will lead to specific activities to reduce emissions and enhance carbon stocks. 	strengthen monitoring capabilities both in terms of human resources, equipment and technologies, and the needed for coordination with departmental governments, and engage in promotion and divulgation to civil society.	
2. Revise the budget for Component 4 (MRV) to include a detailed breakdown by sub-activity, and add capacity building activities, when relevant, for afro-descendant, Mestizo, Indigenous Peoples and local communities in the MRV process.	<p>The R-PP updated the Table 4-1 with a detailed breakdown of activities and an overall budget for MRV in five big topics:</p> <ol style="list-style-type: none"> <li>1. Analysis of monitored variables of the National forest Inventory and its relevance to REDD+</li> <li>2. Expansion, improvement and adaptation of the National Forest Inventory for REDD+</li> <li>3. 3. Provide additional information on how afro-descendants, Mestizos, Indigenous Peoples and local communities will be included in the Readiness phase and how the principle of FPIC may be taken into account.	<p>The revised version of the R-PP highlighted a meeting that took place on June 13<sup>th</sup> organized by the Department of Forestry and the Division of Climate Change that strengthened the dialogue of the R-PP with civil society. In particular the invitation was extended to the Rural Women Association of Uruguay (AMRU), Charrua National Council (CONACHA), Environmental NGO's network, and Mundo Afro (Afro representation group). The R-PP mentions that all organizations invited were thankful for the openness of the Government to interact with them and expressed their interest in continuing being involved in future phases.</p>	Item completed.

Provide additional information on the potential impacts of deforestation and forest degradation on the livelihoods, traditional knowledge and practices of afro-descendants, Mestizos, Indigenous Peoples and local communities.</p>	<p>The new version added a description indicating that on August 2014 the Ministry of Housing, Territorial Ordering and Environment signed an agreement with the Center for Afro Research and Studies (CEIAF). The full Agreement is now displayed on Annex 2 under the title "Agreement to Facilitate the Participation of Local Communities Related to Biological Diversity in the Implementation of the National Biodiversity Strategy ". It aims at characterizing local communities and ethnic groups that directly and indirectly benefit from biodiversity services. The activities under this agreement will specify the type of organization and who are the representatives and / or coordinators. It will also set the ground for a plan to facilitate the participation of local communities and ethnic groups in the implementation of the National Biodiversity Strategy.</p> <p>The plan will consist of an initial diagnosis of the state of knowledge of local communities and the main obstacles to a successful and effective participation of local communities in the implementation process.</p> <p>The R-PP states that this agreement and the activities to be performed, will be the framework and foundation for the inclusion of these communities in REDD + readiness, including the issues of impacts from deforestation and forest degradation.</p>	<p>Item completed.</p>
