#### Developing a Budget for each Component

#### **R-PP Template Guidance**

Countries preparing an R-PP should provide the following information for each R-PP component:

- The initial/planned schedule to fulfil the activities anticipated of that component;
- A budget detailing the financial requirements to support the activities of that component; and
- All requested donor and expected government contributions to cover the financial requirements (including your request from FCPF and any funding from UN REDD, among others).



## Developing a Budget for each Component

## A Budget for EACH Component? Yes, because it:

- Assists a country to clearly identify its estimated costs for readiness
- Prevents duplication of efforts and promotes complementarities
- Helps to identify funding gaps
