Overall Assessments

Grant Objectives:

The Project Development Objective is to carry out a consultative and quantitative analysis of the different land use options for development of the national REDD+ Strategy for Liberia approved by the National Climate Change Steering Committee.

Overall progress from 07/01/2015 to 06/30/2016 with regard to Achieving Grant Objectives:

Comment:

Good progress has been made in implementing the grant supported activities. The activities under the grant are nearing completion and are expected to be completed well within the closing date. REDD+ Readiness outputs are almost finalized including for the Strategic Environmental and Social Assessment, Land cover and Forest mapping and the production of base maps, the development of communications strategy, the development of the National Strategy, the development of the processes for a reference scenario.

Consultations with stakeholders were conducted as part of Liberia#s commitment to a highly participatory process. Through the support of both grants (US\$3.6 million and additional funding of US\$5 million) Liberia intends to submit its R-Package to the FCPF by December 2016 for consideration by the March 2017 FCPF PC meeting.

Overall progress from 07/01/2015 to 06/30/2016 with regard to Implementation of Grant Financed Activities: Comment:

The overall progress of the Grant Implementation over the reporting period is significant. Implementation progress has been slightly delayed due to the Ebola outbreak in Liberia in 2015 that halted all government and consultant activities. However, post-Ebola the pace of activities has picked up significantly. Still, a grant extension of 6 months (to November 30, 2016) was requested by the Government of Liberia and approved by the Bank in May 2016.

Grant follow-up and structure

Description and context of Grant:

The FCPF grant provides funding to support Liberia in carrying out selected key activities outlined in the R-PP for the REDD+. The FCPF support funds a portion of the identified R-PP activities, and will help the Country towards achieving REDD+ Readiness. FCPF is financing major components of the R-PP that have been prioritized by the REDD Technical Working Group. This support is limited to technical assistance, analytical studies, capacity building, goods, operating costs, and consultation processes and does not include the implementation of site-specific REDD+ programs (carbon deals) on the ground.

The grant-financed activities are organized into four components:

Component 1: Support to Coordination of the REDD+ Readiness Process and Consultations

Component 2: Contribute to the design of the national REDD+ Strategy

Component 3: Develop a Reference Level or Scenario (including Forest Cover Mapping and Forest Inventory in Priority Areas)

Component 4: Project Management.

Comment on follow up:

The additional financing of 5M USD from FCPF was approved in September 2015. The Liberia Forest Sector Project (US\$37.5 million) with a single country Trust Fund from NIFCI (Norway) was also approved in April 2016.

OUTCOME

Comments on outcome achieved from 07/01/2015 to 06/30/2016

As a result of the Ebola crisis several contracts were delayed in their implementation, notably for the forest cover mapping, SESA and REDD+ Strategy and certain aspects of developing the reference emissions level and MRV procedures due to consulting firms not willing to return to Liberia or complete consultation processes that required going to the field. With these contracts now underway and close to completion, the grant will deliver on its objectives.

Additionally certain elements of REDD+ Readiness will be supported by the additional funding for the REDD+ process, such as the implementation of the MRV system and development of the REL that build on the activities undertaken in this grant.

The initial studies are implemented with this original 3.6M from FCPF, and additional on-ground studies and activities are covered with the additional financing of 5M from FCPF. The REDD+ readiness work lay ground for Liberia to receive support to its forest sector from Norway, under the Letter of Intent signed in September 2014 (total commitment of US\$150 million equivalent at the time of the signing).

In addition, several of the CSOs are engaged in various initiatives which are complementary to REDD+ and thereby are continually offering useful lessons and insights to guide and strengthen the REDD+ readiness process.

The deliverables by consultants delayed during the Ebola outbreak period, and have caught up with the plan, but are not completed yet.

SESA conducted in accordance with the Common Approach. SESA was prepared, including through a series of consultations, and validated. Six short case study reports on drivers of deforestation were also produced as part of the SESA consultancy.

A consultant has been recruited and is working on the implementation of the REDD+ communication strategy and activities are underway to increase the accessibility of information electronically as well as dissemination of information more broadly.
