Grant Objectives:

The proposed Project Development Objective is to reinforce Burkina Faso#s capacity to coordinate the REDD+ readiness process including a socially and environmentally sound national strategy and other key governance systems for REDD+ implementation.

Overall progress from 07/01/2014 to 06/30/2015 with regard to Achieving Grant Objectives:

Comment:

The grant was effective end of February 2015. It will complement the Forest Investment Project and the teams for both projects are working together. The REDD+ Readiness activities as defined in the R-PP will be designed and lead by a specific lead REDD+ expert. During the period for the GRM (February to end of June 2015), the procurement procedure was held and an expert was identified. however, the expert withdraw at negotiation stage as he found a better position elsewhere. A new recruitment procedure was launched and was successful, but the contract was not signed before the end of the reporting period. Most of REDD+ Readiness activities are planned in the next FY.

Overall progress from 07/01/2014 to 06/30/2015 with regard to Implementation of Grant Financed Activities: Comment:

Despite the political situation, Burkina Faso is moving forward on the REDD+ Readiness agenda, especially with the production of a complete mapping of land use change through Luxembourg project and the pooling of the expertise on REDD+ and Land management inherited from other projects.

However, because the activities have been mostly financed by Lux-Dev and by the Forest Investment Program (both AfDB and World Bank), the FCPF TF itself has not been disbursing yet. The work program for this specific TF should be finalized soon with the support of the Lead REDD+ expert that has been hired at the end of the FY and is now settled in Burkina Faso.

Following the political events and the approval of the Grant in February, the activities before end of June 2015 were mostly enabling activities (procurement, definition of the activity sharing between the FIP and FCPF grants...). The disbursement on the FIP Preparation Grant (PPG) has been delayed, and the team preferred to complete the disbursement on the Preparation grant before starting using the FCPF grant. As the PPG is closing and the key staff have been hired, the FCPF grant should start disbursing very soon and at a quick pace to follow the fast-moving development of REDD+ in the country.
