Grant Objectives:

The Project Development Objective is to design a socially and environmentally viable national strategy for reducing emissions from deforestation and forest degradation as compared to a reference level.

Overall progress from 07/01/2014 to 06/30/2015 with regard to Achieving Grant Objectives:

Comment:

There has been significant improvement in this financial year compared to previous - the Secretariat has been established, disbursement is up from 7% to over 30% and a key component for establishing the strategy is at advanced stage - the establishment of a reference level. Nevertheless as other key activities are lagging the grant objective can only be achieved with grant extension of 6 - 9 months.

Overall progress from 07/01/2014 to 06/30/2015 with regard to Implementation of Grant Financed Activities: Comment:

The Grant Agreement for the REDD+ Readiness Grant was signed in June 2013 and became effective in December 2013, following fulfillment of the effectiveness condition on procurement. Govt of Uganda has strengthened implementation support and procurement progress is being made with the largest contract (reference levels) making satisfactory progress. Smaller contracts are at various stages of contracting. Grant extension of approximately 9 months will be required to fully implement the grant and build required capacity.

Comment on follow up:

Uganda may be able to apply for additional funding from the FCPF REDD+ Readiness fund, of up to \$5 million, following Mid-Term Review and successful implementation of activities as envisaged under current financing within a reasonable time frame. Linkages to Forest Investment Program and Pilot Program For Climate Change Resilience will be discussed in the October FIP Scoping mission. Regional landscape related initiatives also present opportunities including linkage to the Green Climate Fund.

OUTCOME

Comments on outcome achieved from 07/01/2014 to 06/30/2015

The most important outcomes include: (i) the establishment of a national REDD+ secretariat whose capacity is being built and which is begining to build capacity; (ii) the status of forest cover at milestone years is at an advanced stage of completion - (FAO); (iii) overall awareness on the drivers of deforestation and the importance of addressing deforestation is gaining momentum at a community and government/ decision maker level. Various community based REDD + projects are being implemented outside of this program demonstrating that national awareness has been built and communities are interested. These are the most important outcomes.
