#### **Overall Assessments**

#### **Grant Objectives:**

The Development Objective of this grant is to contribute to the development of Indonesia#s capacity to design a sound national REDD+ strategy, develop national and sub-national reference scenarios and establish a forest monitoring and carbon accounting system, consistent with local, regional and national conditions and circumstances

# Overall progress from 07/01/2012 to 06/30/2013 with regard to Achieving Grant Objectives:

#### Comment:

The overall progress reported in this period has covered progress since June 2011.

Based on the recent supervision mission, which was conducted in February 2013, the mission agrees that grant implementation continues to show satisfactory progress despite the delays caused by the recently introduced on-budget on-treasury system. Overall, FCPF has developed good partnerships with local governments and has conducted an impressive number of workshops, information sharing events, focus group discussions and training to the local, national and international stakeholders. It has strategically used the funds to complement the available national budget and could deliver a much higher amount of events and workshops as initially planned.

The supervision mission agrees that a number of highly important results were achieved, such as the SESA process, engagement of sub-national agencies in the REDD processes, collaboration with the broader public on various readiness topics through workshops and lately the disseminating of the results coming out from the field activities. Strengthening the role of local universities also deserves to be mentioned. The mission also recognizes the immense effort of the FCPF to fill the gaps and identify activities that are not covered by other donors and actors. The mission also would like to highlight the immense quantity of work, workshops, engagements and interventions planned and executed throughout the process.

The following are issues identified during the mission that would need further attention:

- a) Communication strategy of the study outputs and project achievements. The FCPF team has produced many studies and interesting results from workshops. The mission agrees that the results of those activities need to be communicated to a wider group of stakeholders and in a more strategic way. The mission also agrees to integrate the outputs where overlaps might occur between the implementing agencies.
- b) Integrated approach in supporting FIP funded Forest Management Unit development: The mission concludes that FIP funded FMU project can take advantage from the current FCPF engagement. As FMU intervention priority areas has not been decided, further coordination is recommended to ensure continuation of FCPF support for REDD+ in relevant FMUs. The mission agrees that FCPF knowledge and expertise on REDD+ could become an asset for the FMU implementation in future.

# Overall progress from 07/01/2012 to 06/30/2013 with regard to Implementation of Grant Financed Activities: Comment:

All targeted outputs were achieved during the estimated implementation period. In many cases, the number of workshops, local engagements and events was actually higher than initially expected because the project teams used additional national budget allocation to deliver on the products. The supervision mission in 2013 found that the overall outcome of those individual programs was achieved but could have been even better if the communication strategy (internet, dissemination, external communication) could be improved.

All activities were previously consulted with project partners, donors, civil society organizations and priorities were defined in a participatory manner.

Financial Management in line with On Budget and On Treasury ##DIPA# planning: The mission agreed that the new national financial management arrangements have created challenges and resulted in disbursement delays in the first year Although, the financial management has significantly improved since then, it remains a challenge and could potentially affect spending performance both for FORDA and Pustanling in future.

The team also committed to deliver the Midterm Review (MTR) on readiness component in Indonesia. FCPF, however, still needs to focus more on communication and dissemination of the results produced.

### **Program Specific Questions**

1. Describe progress in how the Grant activities are being coordinated with other REDD+-related initiatives, including those funded by others.

In relation to the climate finance program, in particular under FCPF and FIP, the World Bank and the GoI have made significant efforts to align the existing and future instruments with the Norway LoI agenda and other donor activities. During the inception phase it was made clear that FCPF would only cover activities that no other donor would cover.

The FCPF and FIP in Indonesia are collaborating closely, and it is expected that the additional finance to the FCPF will finance some of the Readiness activities needed to make FIP investment successful, including capacity building at the local level for the implementation of Forest Management Units (KPH).

As the World Bank is also providing support for other REDD+ and Green Growth related activities and programs involving community development, agricultural development and governance reforms, the WB can often contribute with the coordination efforts between Ministry of Forestry and other stakeholders.

- 2. Describe any important changes in the technical design or approach related to the Grant activities. The grant is being implemented as initially planned.
- 3. Describe progress in addressing key capacity issues (implementation, technical, financial management, procurement) related to this Grant.

Training to FORDA and other members of the Ministry of Forestry in procurement and financial management has been provided throughout grant implementation.

Staff from Ministry of Forestry has participated in technical trainings with support of the FCPF.

# 4. Describe progress in addressing social and environmental issues (including safeguards) related to the Grant. Is the SESA conducted in accordance with the Common Approach?

The main purpose of the SESA is to ensure that social and environmental sustainability concerns are integrated into the preparation of the national REDD+ strategy. However, in the case of Indonesia, the REDD+ Strategy was already prepared in an inclusive and participatory manner, before the SESA process started. SESA was repurposed to address specific strategic needs of the REDD+ Readiness preparation process going forward, such as setting acceptable consultation protocols and harmonizing different REDD related safeguard instruments and principles. SESA has been instrumental in bringing together the national safeguard discussions, specifically the Principles, Criteria and Indicator for REDD+ Safeguards Indonesia (PRISAI) and the Safeguard Information System (SIS) and has contributed thus far with increasing the level of understanding of safeguards and how to make the more operational in the REDD context.

#### 5. Is the ESMF prepared in accordance with the Common Approach?

Following proactive moves on safeguard standards setting for REDD+ on the part of both the REDD+ Task Force, Ministry of Forestry and other stakeholders, readiness in Indonesia has advanced nearly to the point where the country is ready to prepare an integrated Environmental and Social Management Framework (ESMF). The ESMF will lay out the principles, procedures, systems, and protocols (in relation to monitoring, for example) that are relevant for safeguards application to a potential REDD
