

- 1. Land area: <u>+</u>187 millions ha, population: <u>+</u>230 millions
- 2. Total island: > 16 thousands, > 300 tribes
- 3. 33 provinces, > 300 districts, autonomous governance system
- 4. State forest: ±60 % of land area (± 37 % degraded at various levels)
- 5. Forest transition from:

Papua: low historical DD;


Sumatera, Kalimantan, Sulawesi: high historical DD;

FORESTRY CONTEXT & POLITICAL COMMITMENT


National Commitment:

"Reduction of emissions of greenhouse gases by 26 - 41%, and Continue to grow the economy by 7%"

■ Annual deforestation rate went down from 1.15 m. ha/year in 2003 – 2006 to 0.45 m. ha/year in 2010 – 2012

■ POLICY AND REGULATIONS

Significant progress

- REDD+ National Strategy (prepared)
- National Action Plan for CC (26-41%) prepared
- Regulations / REDD+ Management Agency
- LOI extended

REL Progressing, further devt's required

- National REL have been drafted, with sub national calculation at 11
 Provinces as part of national REL;
- * Forest cover data is available from 2000 onwards
- The changes within forest classes will be used to measure degradation

■ MRV

Progressing, further devt's required

- Design for a national MRV system has been prepared & under consultation
- Data collection & capacity building at local level achieved ~ DA-REDD (good practice)

■ Governance Reforms

Further Development Required

- Land / forest tenure clarification (Adat community rights, change in the definition of the State forest domain)
- Forest Management Units (FMU/KPH)
 - over 56 million ha of state forest land across 25 provinces allocated into 600 discrete KPH areas. At least 120 KPH institutions should be operationalized in 2014



INDONESIA REDD+ READINESS PROGRESS



Not yet demonstrating

- Fund for REDD+ in Indonesia (FREDDI) is being designed
- No funding yet for result based

■ Safeguards Further Development Required

- Principles, Criteria and Indicators for REDD+ Safeguards in Indonesia
 (PRISAI) has been developed and adopted in a highly participatory way:
 10 social and environmental principles
- Safeguards Information System have been developed
- Integration of SIS and PRISAI as one national safeguards system in 2014
- Strategic Environmental and Social Assessment (SESA) led by National Council of Forests (DKN) to complement the previous two initiatives

- REL, MRV:
 - Progress in developing a national Reference Emission Level and MRV
 - Periodic review of demonstration activities
- Capacity building:
 - Increased stakeholder knowledge and awareness on REDD+
 - Facilitating the Establishment of REDD+ WG or Strengthening the existing REDD+ WG in 3 Provinces -- Maluku, West Sumatra, and South Sumatra in 2012
 - Prepare natl. submission & natl. position w/ ASEAN Member Countries under UNFCCC
 - Review tools to identify drivers of DD in ASEAN region & PNG
 - Outreach, consultation, review on drivers DD



2. FCPF PROGRESS/ACHIEVEMENT

- Safeguard:
 - SIS)has been developed and tested (SIS REDD+ Website) in Jambi and East Kalimantan
 - National Consultation Protocol has been developed
- Developing Network (Universities, Research Agencies and Training and Education Agencies)
- Current achievement: process of CF district selection, updated PSP database



3. FINANCIAL STATEMENT FOR FCPF

FCPF grant: US\$ 3.6 million (IDR 36 billion)

Spent : US\$ 2.5 million (IDR 23 billion or 78 %)-by MoF & National Forest

Council), US\$ 0.4 million (IDR 4 billion or 85 % -by WB)

US\$ 0,7 million (in progress for 2014)

- Remaining Budget is due to differences in exchange rate
- Will be spent for, among other things:
 - * Policy dialog on REL,

* Implementation of SIS,

* Monitoring PSP,

- * Dissemination of safeguards
- * Preparation and communication of R-Package,
- * CF communication to districts.

WHY FCPF ADDITIONAL FUND IS REQUIRED?

- Additional fund is for REDD+ readiness towards result based payment (C-fund)
- National level → improvement is still required for MRV mechanism/ determination of REL/RL, financing and benefit sharing, safeguards, engagement of private sectors
 - Policy intervention for results based payment (carbon fund)
- Sub-national level → filling gaps for MRV mechanism/RL, financing and benefit sharing, implementation of Safeguards, strengthen local government
 - Capacity building


