What is Forest Governance & Legality Addressing under FLEGT-VPA?

- Deforestation/Illegal Logging
 - Use of Export and Domestic Market levers
- Good governance
 - Multi-actor steering (participatory governance)
 - Improved law enforcement (LAS implementation)
 - Re-alignment of (dis-jointed and obsolete) legislation with reality - legislative reform
- Improved access of communities to resources
- Responsible and viable industry
- Sustainable forest management





Governance Focus under REDD+

- Forest legislation and policy reforms to constrain drivers of deforestation and degradation (DDD)
- Address problems of weak institutional capacity
 & coordination, accountability, transparency
- Enhance and sustain stakeholder participation
- Address illegal logging and other forest illegalities through improved law enforcement
- Institute conflict resolution mechanisms
- Institute and sustain REDD+ safeguards







 - Predictable and sustainable finance to deliver the real and verifiable emissions
 - MRV of carbon as well as information system for safeguards could maximise the effectiveness of REDD+

Development & Regulation of Domestic Market	Security of resources/law & order	Internal policy processes
Legislative Reform	Supportive legislative environment	Internal policy processes
Industry Restructuring	Medium-long term national socio-economic stability	Internal policy processes
Sustainable Forest Management	Long-term environmental & socio-economic stability	Internal policy processes

Understanding the difference in Dynamics:



Consultation/Negotiation vs Implementation

- The dynamics of stakeholder participation differs depending on which phase you look at
 - Negotiating is very exciting
 - Implementation not so exciting
- The dynamics are dictated by prevailing & anticipated incentives
- Not all that is agreed will necessarily be implemented with same fervour





What Opportunities: REDD+/FLEGT

- REDD+ can give impetus to the elements of FLEGT that require re-energizing in implementation
 - Multi-actor dialogue
 - Issues of right of access to the resource
 - Adequate, predictable & sustainable finance for protecting natural forests and enhancing forest carbon stocks





WAY FORWARD





Way forward for FLEGT & REDD+

- Need for increased clarity on roles & objectives of FLEGT & REDD+ to:
 - identify areas of coordination and strengthening of their objectives
 - address weaknesses and gaps for better harmonisation and integration
- Common approach to communication
- Integrated approach in promoting the two initiatives across governments and within governments



Way forward for FLEGT & REDD+ cont'

- Integrated approach in engaging with the private sector to achieve objective of both initiatives
- Increase understanding and synergistic roles of two initiatives
- Compartmentalized approach to implementation (& development) of initiatives
 - Delinked implementation will work against both initiatives
