Composition and Selection Criteria

- Composition – 2 groups:
 - 14 members from REDD Country Participants
 - 14 members collectively from Donor Participants and Carbon Fund Participants (“Financial Contributors”) – equal representation from both groups
- Selection:
 - Each group elects its 14 representatives, based on each group’s principles/election criteria

PC Members

- Term: One year until next Annual Meeting
- PC members are representatives of their constituency and should regularly consult their constituency
- Participants that are not PC members can participate in the PC meetings as observers

 - One year until next Annual Meeting
