I. Introduction – recap of PC10 strategic discussions in Berlin

- PC10 (Berlin) October 2011 requested FMT to present a detailed proposal and budget estimate for "analytical work, knowledge management and centrally sourced activities" by PC12
 - Based on a quick assessment of REDD+ countries readiness needs
 - To include South-South exchange and linkages between REDD+ and FLEGT
 - Take into account similar existing or planned activities undertaken by other initiatives
 - Take into account FMT's capacity

I. Introduction – recap of PC12 discussions in Santa Marta

- FMT presented the proposal on additional activities at PC12
- PC requested the FMT to revise the proposal taking into consideration the following (Resolution PC12/12/2012/5):
 - Final report of country needs assessment
 - Similar existing or planned activities undertaken by other initiatives and comparative advantage for delivery (specifically UN-REDD)
 - Prioritization of activities with regard to global learning value
 - FMT's capacity
- Approved US\$200,000 for one workshop on social inclusion

II. Country Needs Assessment - Update

- Country Needs Assessment jointly with UN-REDD
- Methodology presented at joint UN-REDD/FCPF Meeting in Paraguay in March 2012
 - Desk assessment
 - Six in-depth country assessments (2 from each region), including five
 FCPF countries
 - Survey of all 52 FCPF and UN-REDD countries
- Draft report presented at pre-PC meeting in Santa Marta and report revised since
- Key findings of final report presented in pre PC workshop in Brazzaville

II. Country Needs Assessment – Findings (1)

- Priority needs
 - Governance and REDD+ strategy and implementation frameworks, including
 - Legal and Policy review
 - Benefit sharing
 - Safeguards
 - Procedures for consultation and participation
 - Grievance redress mechanisms
 - Reference levels
 - MRV
 - Capacity building for CSOs, NGOs and IPs

II. Country Needs Assessment – Findings (2)

Specific aspects

- Governance: sub-national structures (provincial/district), national coordination structures (cross-sector agreement), benefit sharing, consultation and participation
- REDD+ strategy and implementation frameworks: drivers of deforestation, safeguards, prior experiences, land tenure, 'carbon rights', South-South exchange platforms
- Reference levels: build national technical capabilities
- Monitoring: MRV capacity on specific aspects (e.g., updating inventories, forest carbon measurements, emission factors), monitoring co-benefits
- Capacity building for CSOs, NGOs and IPs: training on procedures for consultation and participation, FPIC
- Policy and legislative review,
- REDD+ pilot projects: additional support

II. Country Needs Assessment – Joint Response of FCPF and UN-REDD

- FMT and UN-REDD held joint discussions in preparation for the October 2012 meetings in Brazzaville
- Key areas of support amongst the initiatives have been aligned to avoid duplication of efforts. Joint response (paragraphs 4-9 of FMT Note)
- FMT has revised its proposal on additional activities in coordination with UN-REDD's budget proposal (October 2012)
 - Specific areas of support within MRV and Reference levels discussed with FAO. FCPF will focus on developing decision support tool for RL and training tools for MRV
 - Legal and policy review, and land tenure themes to be led by UN-REDD
 - Development of registries will be led by FCPF
 - Private Sector engagement in coordination with UNEP

III. Proposal – Factors for Inclusion

- Factors considered in reaching the proposed additional activities
 - Country Needs Assessment, especially priority needs
 - Previous discussions on strategic directions of FCPF
 - Focuses on technical aspects where guidance, tools, recommendations through case examples could be of use/be adapted by several REDD countries
 - Excludes activities not eligible for support through the RF (e.g., REDD+ pilots)
 - Excludes activities that are relevant for implementation by countries (e.g., institutional strengthening)
 - FMT capacity
 - · External experts and relevant staff from other units
 - Comparative advantage of the FCPF

III. Proposal - Activities not included

- Excludes activities being addressed by others (e.g., land tenure, legal preparedness [UN-REDD], broader governance work led by FLEGT, bilateral programs)
- CSO/IP Program already approved by PC so included in base budget and not reflected as an additional activity
- Other activities mandated by the PC are included in the base budget and are not reflected as an additional activity (e.g., CF WG on Methodological and Pricing Framework, M & E Framework)

Additional Considerations

Activities not prioritized

 The proposed activities are strongly interlinked and complement each other, in order to assist countries in reaching REDD+ readiness in a holistic manner. The proposed activities are presented as an integrated work program and have not been prioritized.

Activities started in FY13 likely to continue into FY14

- The activities are likely to continue in FY14, with an indicative FY14 budget estimate of \$1.7 million
- If the work program continues, some adjustments will be made based on the results achieved in FY13. PC approval of the FY14 budget will be solicited in June 2013

Current agreed prioritization for budget allocations

Higher priority

- \$3.6 million grants up to PC14 (March 2013) (Para 2.i.a)
- \$5.5 million for Additional IP/CSO Program over 4 years (Para 2.1.b)
- Up to \$13.4 million for enhanced capacity for dispute resolution (Para 2.i.c)

Lower priority

- Additional grants of up to \$5 million for those making significant progress (Para 2.ii.a)
- Analytical work, knowledge management, South-South exchanges ("Additional activities") (Para 2.ii.b)
- Possible reopening to new REDD+ countries (Para 2.ii.c)
- No priority agreed in lower priority items

Expected grants to 35 REDD Country Participants. All 37 originally selected into the FCPF but excluding Tanzania (bilaterally funded) and Equatorial Guinea (PA not signed by February 1, 2012). Steady operational budget through FY16 (including an estimate for continuing additional activities), with 20%

annual cuts thereafter.
