Composition and Selection Criteria

- Composition 2 groups:
- 14 members from REDD Country Participants
- 14 members collectively from Donor Participants and Carbon Fund Participants ("Financial Contributors") – equal representation from both groups
- Each group elects its 14 representatives, based on each group's principles/election criteria

PC Members and Non-Members

- Term: one year until next Annual Meeting
- PC members are representatives of their constituency and should regularly consult their constituency
- Participants that are not PC members can participate in the PC meetings as observers

Rules of Procedure of the PC provide:

- 8 PC members serve as the Bureau:
 - 5 REDD Country Participants
 - 3 Financial Contributors
- Functions:
 - Liaise with and provide guidance to the Facility Management Team
- Selection:
 - Members from REDD Country Participants and Financial Contributors will select their representatives
- Term:
 - one year until next Annual Meeting

Co-chairs of the Participants Committee

Rules of Procedure of the PC provide:

- The Bureau will submit nominations of two Co-Chairs to the PC Members and the FMT, for approval by the PC at the beginning of the PC Meeting
 - One Co-chair from the REDD Country Participants
 - One Co-Chair from the Financial Contributors

Action by FCPF Participants

- 1. REDD Country Participants and Financial Contributors elect their 14 PC members, respectively
- 2. Elected PC members of REDD Country Participants and Financial Contributors, nominate respectively:
 - PC Bureau:
 - 5 representatives from REDD Country Participants
 - 3 representatives from Financial Contributors
 - Co-chairs for PC10:
 - 1 REDD Country Participant
 - 1 Financial Contributor
- Caucus groups will meet today at 17:30 to choose their representatives
- Results to be announced tomorrow morning, at the start of PC10 meeting
