National Forest Monitoring Systems:

5. *Also acknowledges* that Parties' national forest monitoring systems may provide, as appropriate, **relevant information for national systems for the provision of information on how safeguards** in decision 1/CP16, appendix 1, are addressed and respected;

MRV:

23. *Invites* Parties and admitted observer organizations to **submit** to the secretariat, by 25 March 2013, their **views related to non-carbon benefits** resulting from the implementation of the activities referred to in 1/CP16, paragraph 70;

24. *Requests* the secretariat to compile the submissions referred to in paragraph 23 above into a miscellaneous document for consideration by the Subsidiary Body for Scientific and Technical Advice at its thirty-eighth session;

25. *Requests* the Subsidiary Body for Scientific and Technical Advice to consider the submissions referred to in paragraph 23 above with the aim of reporting progress made and any recommendations to the Conference of the Parties at its nineteenth session;

SBSTA text on National Forest Monitoring Systems and MRV was NOT adopted.

The draft text is attached as an annex to the Chairs Conclusions, and will inform discussions next year.

LCA text (adopted)

25. Decides to undertake a **work program on results-based** finance in 2013, including two in-session workshops, subject to the availability of supplementary resources, to progress the full implementation of the activities referred to decision 1/CP16, paragraph 70;

28. Decides the aim of the work program is to **contribute to the ongoing efforts to contribute to the ongoing efforts to scale up and improve the effectiveness of finance** for the activities referred to in decision 1/CP16, taking into account decision 2/CP 17 paragraphs 66 and 67;

LCA text (adopted)

29. *Also decides* that the work program will address options to achieve this objective, taking into account a wide variety of sources as referred to in decision 2/CP.17, paragraph 65, including:

- (a) Ways and means to transfer payments for results-based actions;
- (b) Ways to incentivize non-carbon benefits**
- (c) Ways to improve the coordination of results-based finance

LCA text (adopted)

34. *Recognizes* the need to **improve coordination of support for the implementation of the activities** referred to in decision 1/CO16 paragraph 70, and to provide adequate and predictable support, including financial resources and technical and technological support, to developing country Parties for implementation of those activities;

35. *Requests* the Subsidiary Body for Scientific and Technological Advice and the Subsidiary Body for Implementation, at their thirty-eighth sessions, to **jointly initiate a process with the aim of addressing matters outlined in paragraph 34 above**, and to consider existing institutional arrangements or potential governance alternatives including a body, a board or a committee, and to make recommendations on these matters to the Conference of the Parties at its thirty-ninth session;

36. *Invites* Parties and admitted observer organizations to **submit** to the secretariat, by 25 March 2013, **their views on the matters referred to in paragraphs 34 and 35 above**, including potential functions, modalities and procedures;

40. Also requests the Subsidiary Body for Scientific and Technological Advice, at its thirty-eighth session, to initiate work on **methodological issues related to non-carbon benefits** resulting from the implementation of the activities referred to in decision 1/CP.16. paragraph 70, and to report on this matter to the Conference of the Parties at its nineteenth session;
