Disbursement has improved in the last FY given that the recruitment of firms and individual consultants for the various analytical tasks has been finalized and are ongoing. As of June 30, 2017 Disbursement has reached 42% of the total grant, while around 97% of the grant amount is already committed to activities through the end of 2018.

#### Comments on outcome achieved from 07/01/2016 to 06/30/2017

Significant progress has been recorded with regards to achieving the grant objectives. The administrative bodies created to guide and manage the REDD+ process (the National REDD+ Committee, the REDD+ National Working Group, and the REDD+ National Coordination) are fully in place and operational. REDD+ regional focal points are also operational in the country#s five regions. Information sessions and consultations on REDD+ have been carried out throughout the country with a variety of stakeholders, resulting in their strong involvement in the REDD+ process. The main stakeholders are equipped with roadmaps to enable them to carry out sensitization activities at the grassroots level. In addition, thematic working groups have been established with the different sectoral ministries to ensure their input to the REDD+ process. All the studies necessary to inform the strategy have been launched and, while some have been completed and validated, the remaining studies should be completed by December 2017. A draft 0 of the REDD+ strategy was developed. Finally, the activities related to environmental and social safeguards have been launched.

## Comment on planned and actual Output

## Comment on component implementation progress

Component 1: All the implementing agencies have been set up and functioning including the National Committee for REDD+, the REDD+ regional focal points have been nominated in the country's five regions. All the twelve planned studies were launched and are to be completed by December 2017;

Accountability and transparency: The legal framework and institutional arrangements for effective management of the REDD + process in Togo are fully in place and are operational. The legal framework consists of various legislative texts ensuring the independent and transparent operation (financially and in terms of decision-making) of the REDD + management bodies in Togo.

Consultation process: As part of the REDD + process in Togo, the National Commission for Sustainable Development (CNDD) and the Local Commissions for Sustainable Development (CLDD) serve as platforms for consultation and participation. To this end, the project national coordination Unit has accompanied the establishment and operationalization of the Prefectural Commissions for Sustainable Development (CPDD). A total of 36 CPDDs out of 39 are in place.

Dissemination of information and access to information: To ensure a good information access and dissemination to the various stakeholders, the National Coordination Unit has developed a communication strategy.

Component 2: Preparation of the national strategy REDD+. In preparing the national REDD+ strategy, the Togo readiness proposal proposes first to examine how current loopholes in land use and forest law, policy and governance contribute to deforestation and forest degradation and to identify possible solutions. Many studies were carried out.

Sub-component 2a. Assessment of land use, land-use change factors, laws, policies and forest governance. On the basis of an initial workshop to prepare ToR for analytical studies with stakeholders, in December 2015, the REDD+ project National Coordination Unit coordinated the launching of eight analytical studies to assess land use, drivers of changes in land use, forest law, policy and governance to identify the main drivers of forest deforestation and / or degradation sustainable forest management and carbon stock enhancement activities.

Subcomponent 2b: Strategic Options for REDD+. Togo hopes that the national REDD + strategy builds on national priorities for sustainable development, UNFCCC guidelines and, more recently, commitments under the Paris Agreements.

Sub-Component 2c: Implementation Framework. On the basis of the annual work plan for 2017, the project National Coordination REDD+ Unit is working on the institutional, economic, legal and governance arrangements needed to implement REDD+ strategic options. Implementation of REDD+ strategic options is specific to land use patterns (forest, crops, cash crops, pastures, etc.) and the legal and social context.

Sub-Component 2d: Social and Environmental Impacts of REDD Readiness. As part of the integration of environmental and social safeguard measures, two experts (an environmentalist and a social development specialist) were recruited to strengthen the EESS unit . The management of this component is carried out in close collaboration with The National Agency for Environmental Management (ANGE), which supervises and ensures that the entire SESA process is carried out in accordance with the relevant national provisions (and World Bank / FCPF criteria). The ANGE has appointed an agent who supported the National Coordination Unit, ensureing close monitoring of activities.

Component 4: Forest monitoring systems. It includes the national forest monitoring system and information system on multiple benefits, governance and Safeguards.

The preparation of the ESMF has recently been launched, in accordance with World Bank safeguard policies, which are in line with the Common Approach.
